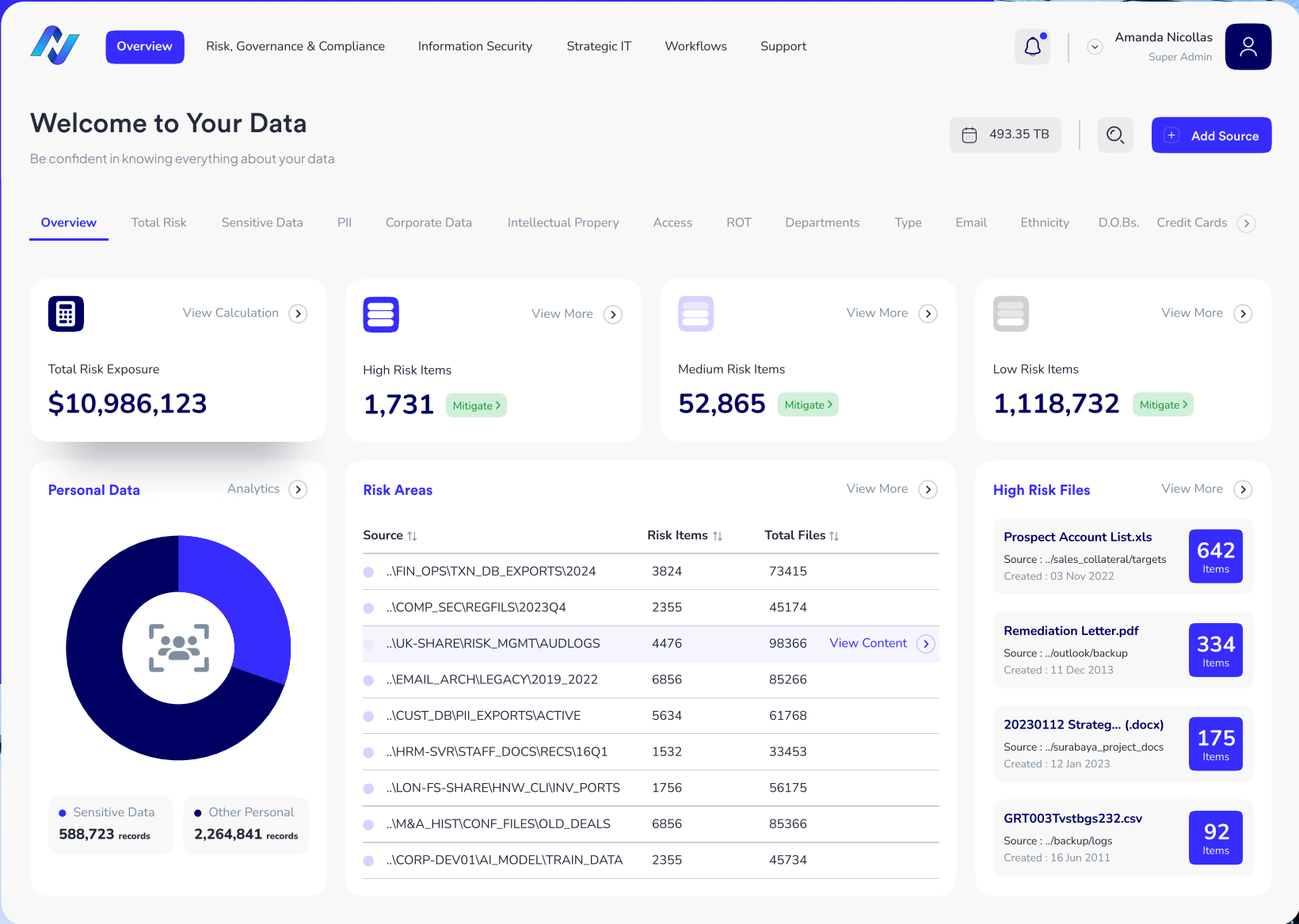

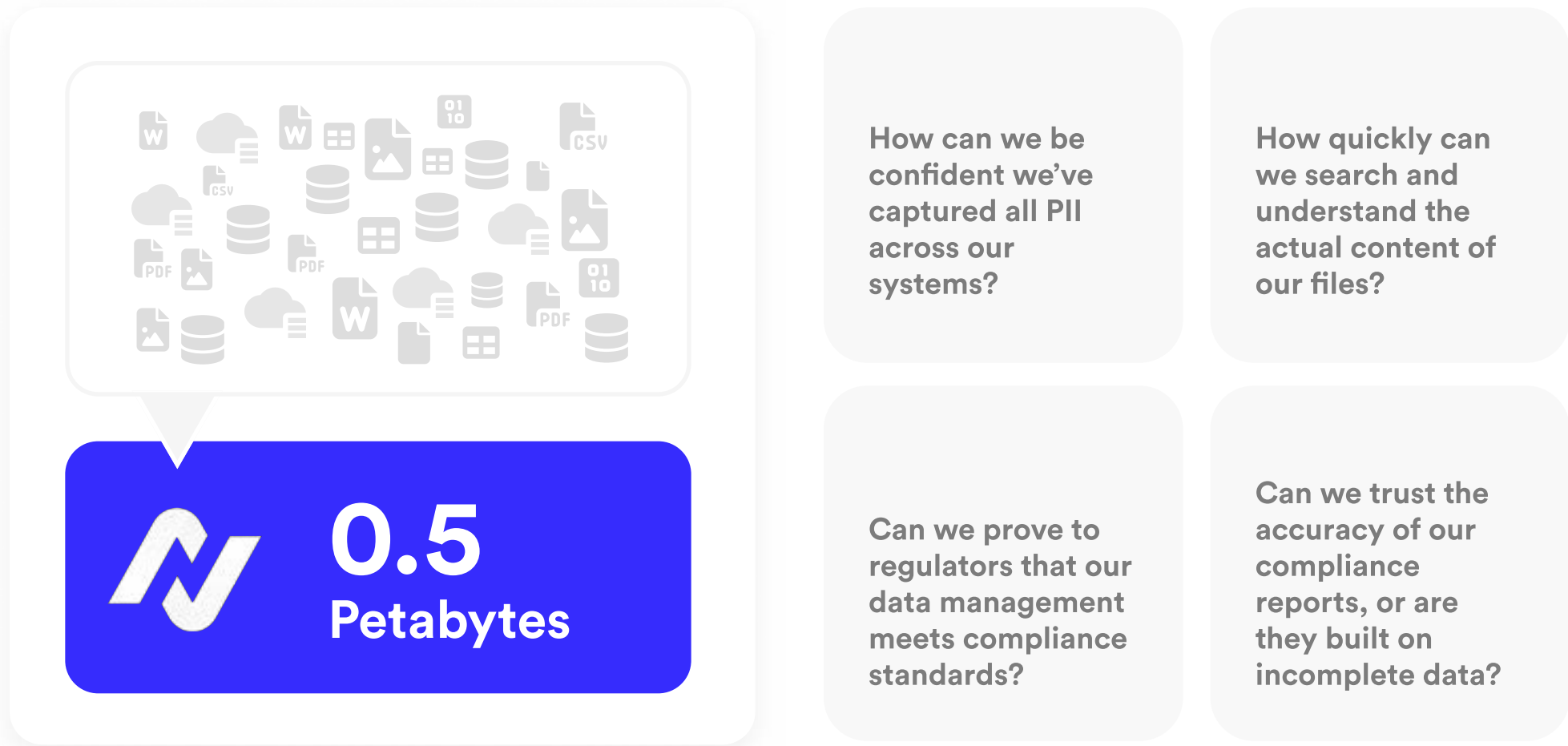
Confidence in their data management, risk controls, and regulatory compliance was paramount. However, they lacked a complete and detailed view of their data, making it impossible to manage risk effectively.

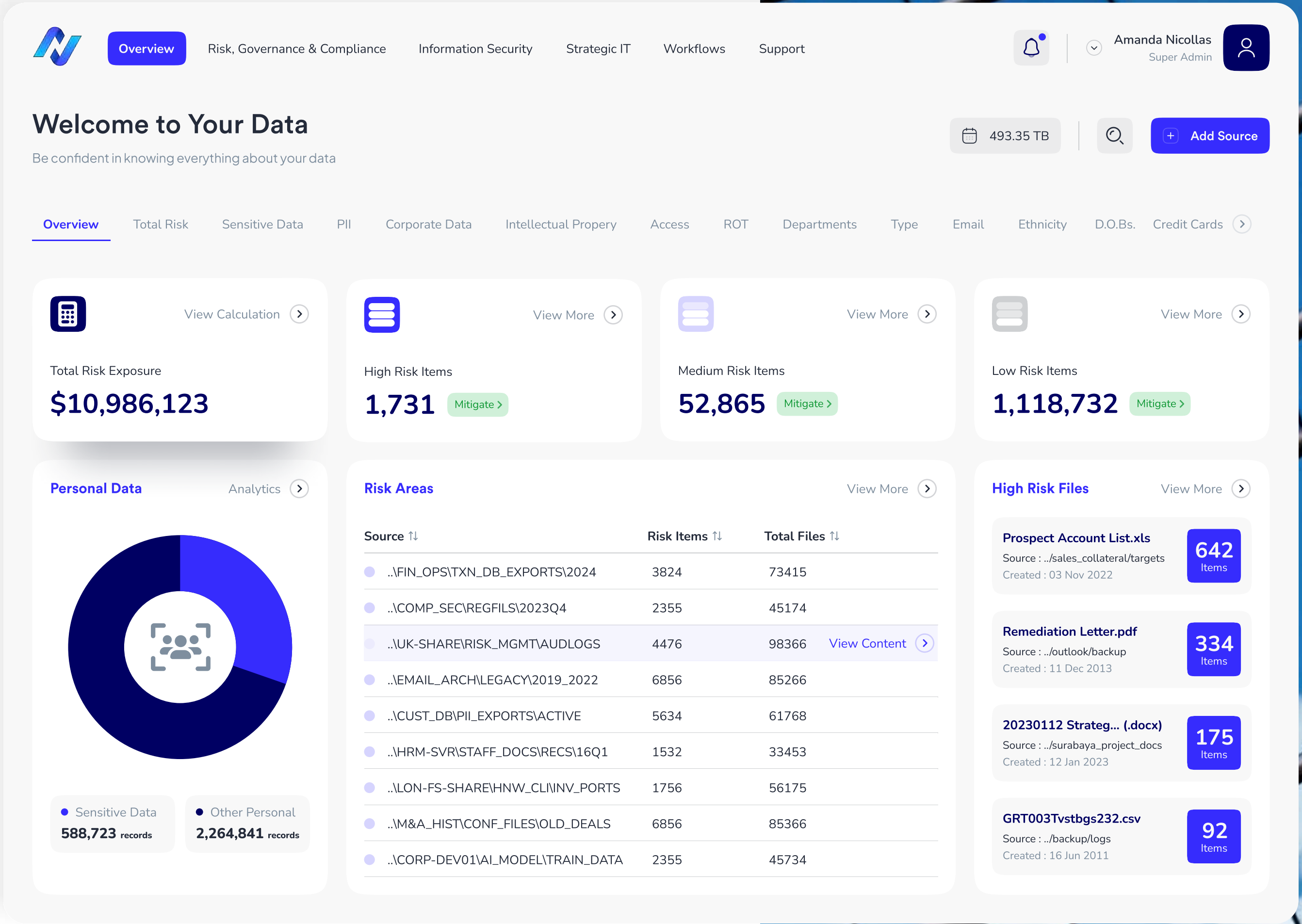

Risk Reduction and Automated Compliance

Within the live, fully searchable catalogue of structured and unstructured data the \$12m of risky data was prioritized based on impact. Through the platform the client was able to systematically reduce their risk - tagging, redacting and remediating in bulk through the NowVertical platform.
