Year in Review

2025 was not the year we had hoped for in the fight against plastic pollution. The UN treaty negotiations, which so many of us had worked toward for years, remained unresolved, leaving the world without the binding global framework this crisis demands. I could write about that at length. But I will focus instead on the good news - and there is real good news:

**181,983,864 kilograms
(401,205,743 pounds)**

of plastic diverted from nature - that is nearly 60 billion 3-gram sachets or 12 billion 15-gram bottles kept out of rivers and oceans, and paid for by companies choosing to act. Every tonne third-party verified. Every project audited. This is not a projection or a pledge, it is impact that has already happened, in communities that needed it most.

Across the world in 2025, governments moved forward on Extended Producer Responsibility regulation without a global mandate to do so. The EU enacted its Packaging and Packaging Waste Regulation, making EPR mandatory across all member states by 2027. Kenya introduced EPR legislation in May.

Oregon began full implementation of its packaging EPR law in July. Canada's federal plastic registry completed its first reporting cycle in September. Malaysia set a

path to mandatory EPR from 2026. Thailand is finalising its EPR Act. And California advanced SB 54, the most ambitious packaging EPR law in the US, mandating a 25% reduction in single-use plastic at source alongside recycling targets. This is the architecture of a global system being built piece by piece, without waiting for a global treaty that has not yet arrived.

In the Philippines, where PCX was born, companies were required to recover 50% of their plastic packaging footprint by the end of 2025. Sixteen of these companies - our partners - went to 100%. That is not compliance. That is leadership.

Under the Plastic Pollution Reduction Standard (PPRS) we now have 45 registered projects across 15 countries, supporting more than 140 partners worldwide. The headwinds are real. But so is this: More countries have EPR laws today than at any point in history. More companies are taking verified responsibility for their plastic footprint. And more communities, through the recyclers and collectors who are the real infrastructure of this system, are turning plastic from a crisis into a livelihood.

The system we need is being built by governments that chose to act without waiting, by companies that chose to lead rather than merely comply, and by the people on the ground who have always borne the cost of inaction. We are proud of what PCX Markets contributed to that in 2025. And we are clear-eyed about what 2026 will demand.

The world has produced about 9 billion metric tons of plastic since the 1950s. Today, only 9% of plastic waste is recycled - 19% is incinerated, and 72% is either landfilled, dumped, openly burned or ends up in the environment. Even if we were to reduce production from today's levels by 40% by 2050, the world would still produce another 11 billion tons that needs to be responsibly managed.

PCX Markets is on a mission to build a future where no plastic ends up in nature. Our global plastics responsibility platform helps companies meet their voluntary sustainability goals and legal compliance requirements through upstream reduction consulting, packaging EPR compliance software, access to verified recycled resins, and recovery project impact through our transparent marketplace and registry.

A certified B Corp, PCX meets B Lab's rigorous standards of accountability, transparency, and social and environmental impact. To date, we have funded the cleanup of 401 million pounds (181.9 million kgs) of plastic waste worldwide, contributing to a cleaner environment and stronger local communities.





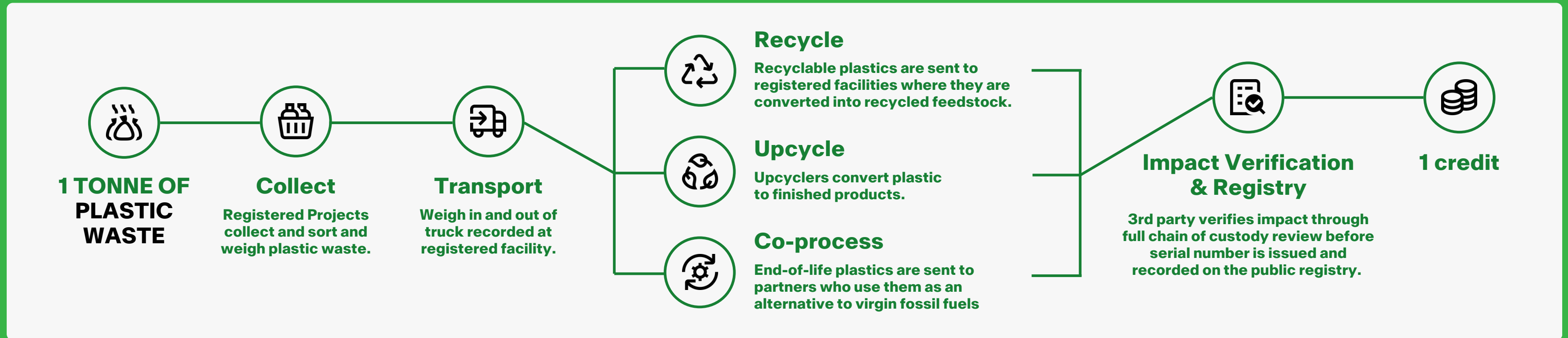

06 Where We Work

In 2025, we expanded our global footprint from 12 to 15 countries, and added seven collection, recycling, and upcycling projects, including new projects in Bangladesh, Brazil, and Cambodia.

Bangladesh

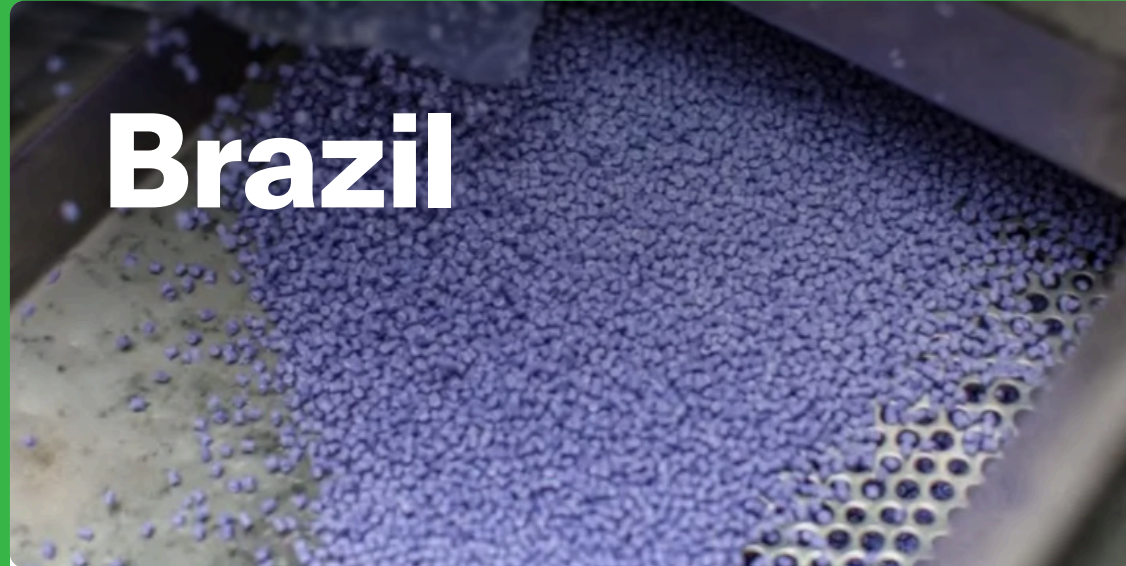


Community Collection and Upcycling of Mixed Plastics

This project partner addresses the urgent issue of unrecycled plastics by building a decentralized, community-powered recycling ecosystem.

In Bangladesh, only 31% of plastic waste is recycled because low-value plastics are often too contaminated to process economically. As a result, they accumulate in landfills and clog waterways. This project employs more than 3,500 community waste collectors and 30 local subcontractors to recover plastic waste from landfills, dumpsites, and streets.

Brazil



Recycling of PP, PS, LDPE and PVC plastics

This project partner sources post-consumer plastic waste through partnerships with four NGOs that lead community-based collection initiatives.

Brazil generates nearly 500 billion single-use plastic items each year, while inadequate waste management results in 1.3 million tonnes of plastic entering the ocean every year. This project mechanically recycles plastic waste, reducing ocean pollution while producing recycled feedstock that displaces virgin plastic.

Cambodia



Ocean-bound Community Collection and Neutralization of Mixed Plastics

This project tackles plastic pollution in the Mekong, Tonle Sap, and Bassac rivers, vital waterways that sustain millions of people, support rich ecosystems, and connect vibrant communities, but are increasingly choked by plastic.

To stop plastic before it reaches the ocean, cleanup teams collect waste daily within 200 meters of the riverbanks. Plastic is pre-sorted at riverside collection sites, then re-sorted at the project facility.

08 Featured Plastic Recovery Projects



Indonesia

Recycling of PET

This project recycles plastic waste that falls outside Indonesia's formal waste collection system, where limited infrastructure leaves an estimated 70% of plastic waste mismanaged.

This project partner purchases plastic waste from informal sector collectors and local community organizations that collect it from residential areas, streets, and shops and recycles it into high-quality flakes. Revenue from credit sales will fund the collection of more plastic, improve payments for waste pickers, and expand processing capacity.



Thailand

Community Collection and Recycling of HDPE, LLDPE, PP

This project partner purchases HDPE, LLDPE and PP, including single use plastics, from aggregators, such as junk shops, who buy the plastic waste from community collectors and informal sector waste pickers.

This project sorts, cleans, and sends the plastic to its mechanical recycling partner, which produces post-consumer recycled plastic resin that meets the Global Recycled Standard (GRS). The project will use revenue from credit sales to pay waste pickers more for plastic, to ensure more plastic is collected and recycled in a closed loop, circular system.



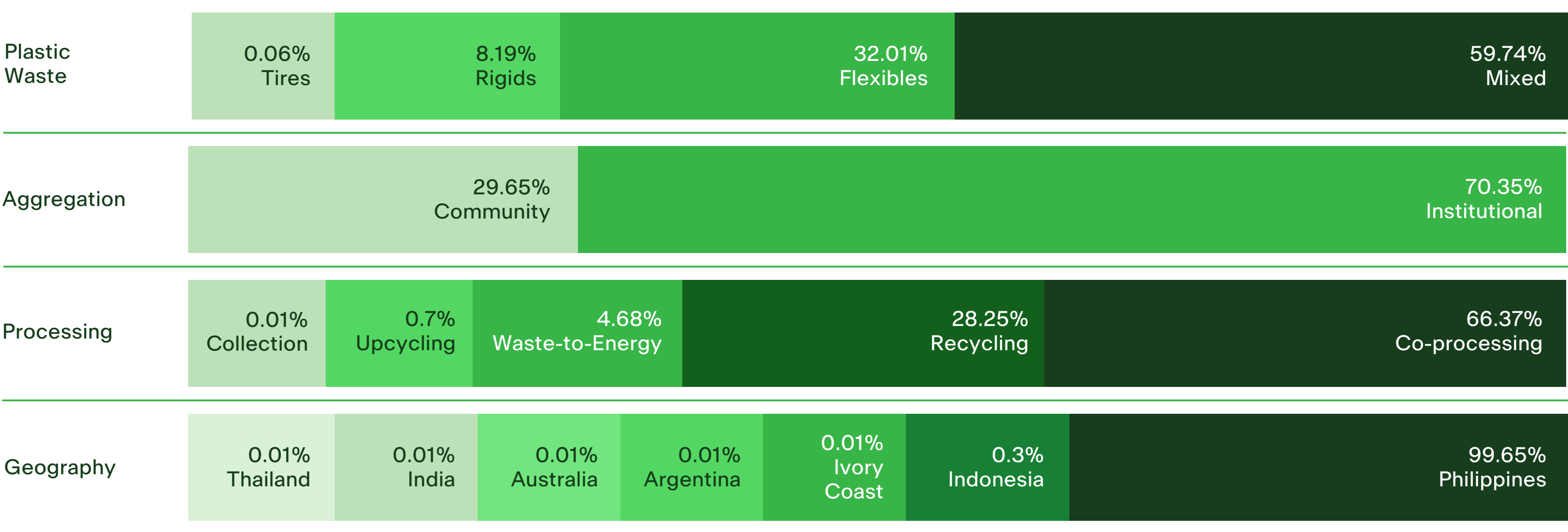
Sri Lanka

Collection and Recycling of HDPE and PP

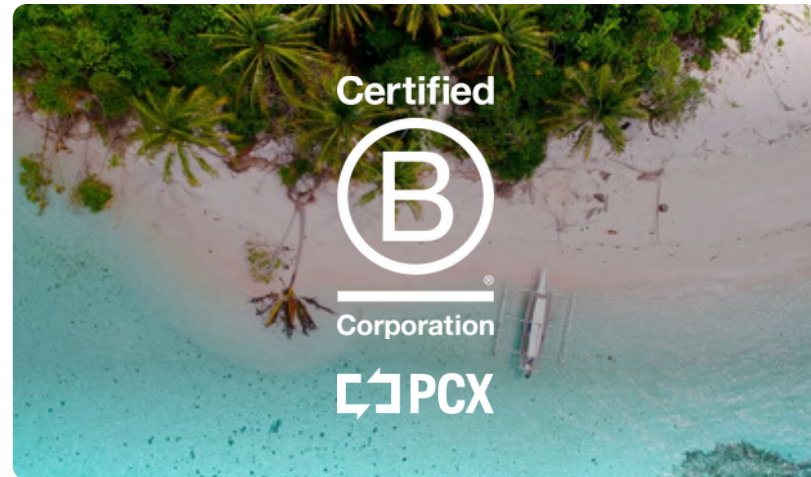
This project addresses the growing volume of post-consumer plastic waste, which ends up in landfills or water bodies, impacting the ecological footprint and natural habitats in Sri Lanka, an island nation.

Recyclable plastics for this project are collected through local communities and waste collection networks. Through mechanical recycling, these plastics are transformed into valuable "regenerated raw materials", reintroduced into production cycles, and used to manufacture new products, promoting the circular economy.

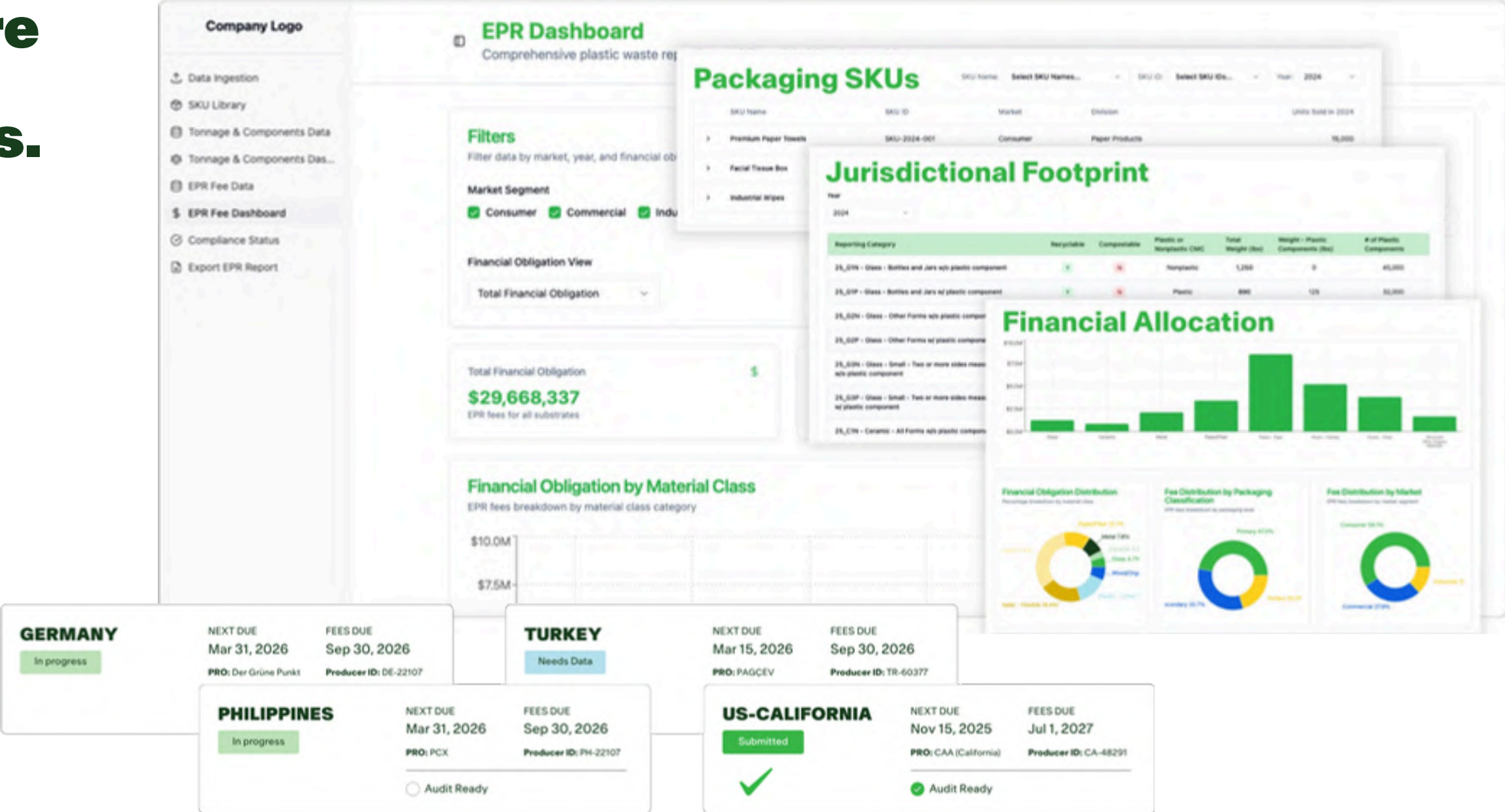

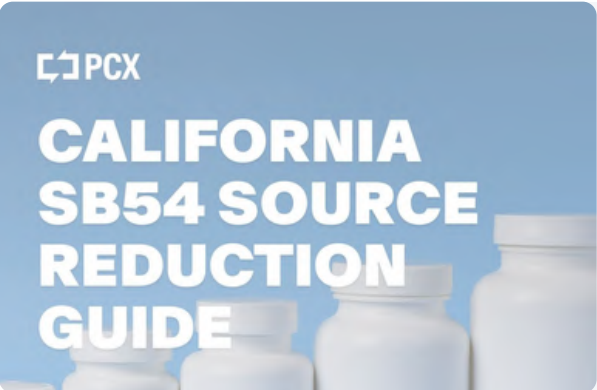

2026 Outlook
