Longboard aims to deliver absolute returns and true diversification through its low-correlation, liquid alternative mutual fund. Utilizing systematic trend-following models, we seek to enhance portfolio resilience across all market environments.

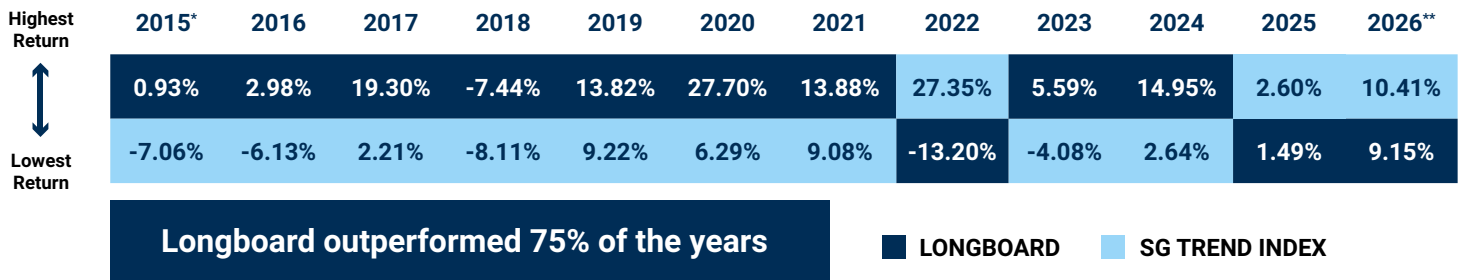
As of May 31, 2026, Longboard's trend following strategies surpassed the SG Trend Index over the 2-year, 3-year, and 10-year periods, generating +374 basis points of annual excess performance in the past decade.

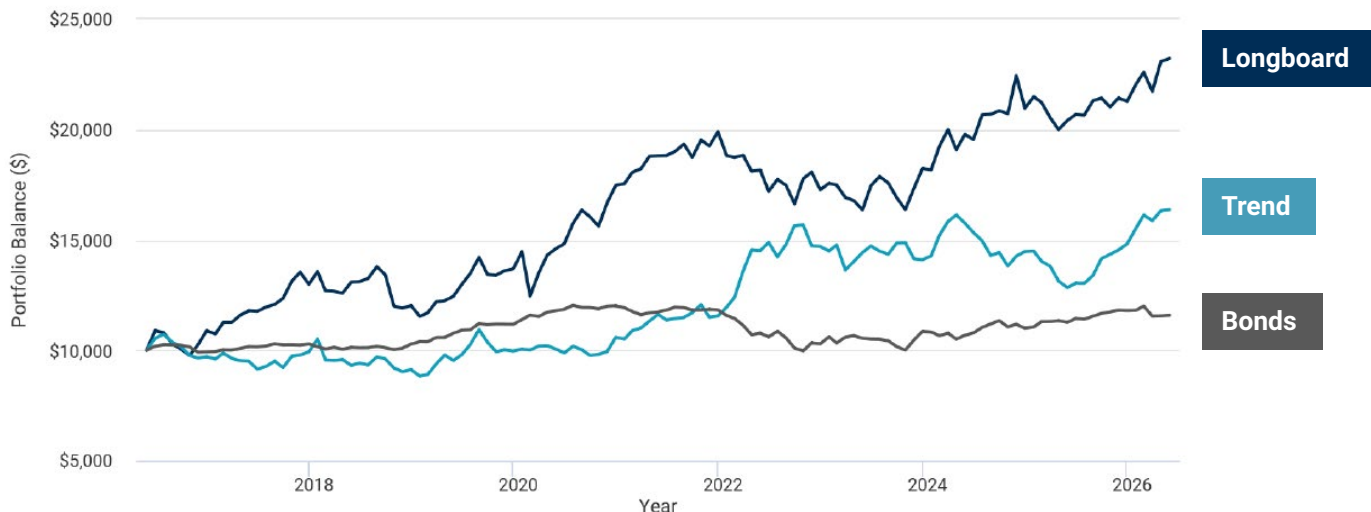

Updated Longboard Fund (LONGX) Commentary - Through May 31, 2026

The Longboard Fund returned +0.62% in May, bringing year-to-date performance to +9.15% as of May 31, 2026. Following April's strong +6.21% gain, May was a period of consolidation. Market leadership narrowed modestly amid ongoing geopolitical and macro uncertainty.

Equity exposure remained steady at 80.33% across 897 positions. The fund's highly diversified approach, spread across hundreds of individual micro-economic trends rather than concentrated themes, continued to provide effective insulation from sector-specific volatility.

Adaptive Trend Identification

Longboard's quantitative models systematically identify and follow only the most persistent trends across hundreds of individual companies.

As the market consolidated after April's broadening momentum, the portfolio remained positioned in the same small- and mid-cap trends and non-mega-cap leadership themes that drove strong first-half performance. No major rotation or de-risking was required.

Disciplined Risk Management

The fund's systematic risk controls remained fully engaged throughout the month. Exposure adjusts dynamically based on trend strength and volatility, allowing for rapid de-risking and rotation into low-correlation T-Bills when trends weaken. This structured approach directly addresses investor loss aversion by seeking to prioritize downside risk management and limiting drawdowns. This is an attribute many investors value when navigating late-cycle markets with macro risks.

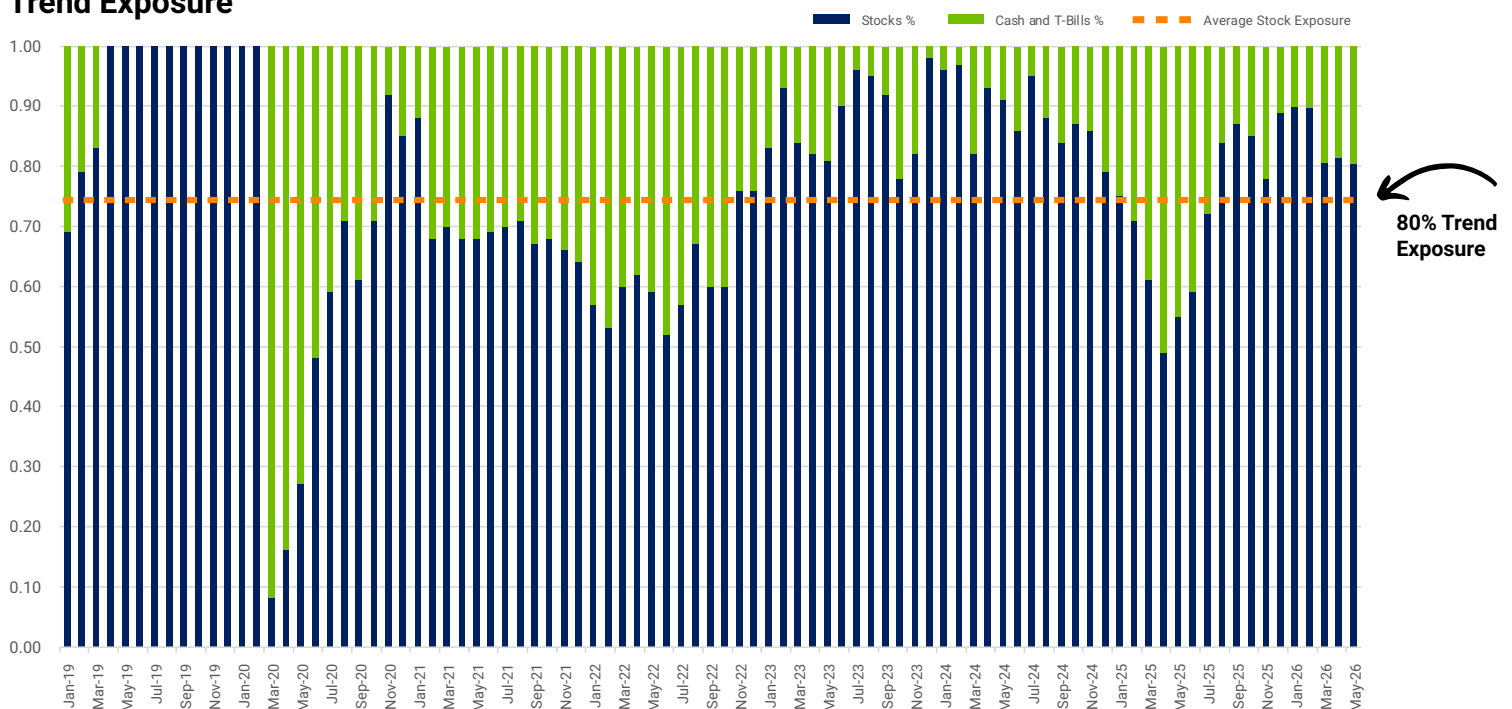
Portfolio Snapshot (as of May 31, 2026)

The portfolio held 80.33% net long equities across 897 positions, maintaining broad diversification. Positioning continues to emphasize micro-economic trends across non-overlapping sectors, with no single theme representing a concentrated bet.

The fund's innovative strategy seeks to deliver meaningful diversification against macro risks. This approach helps us reduce vulnerability to broad market reversals, policy shifts, or geopolitical shocks.

The second half of 2026 macro environment, characterized by elevated CAPE ratios, historically low dividend yields, and rising long-end yields, further underscores the value of this diversified trend-following approach over concentrated equity or fixed income allocations.

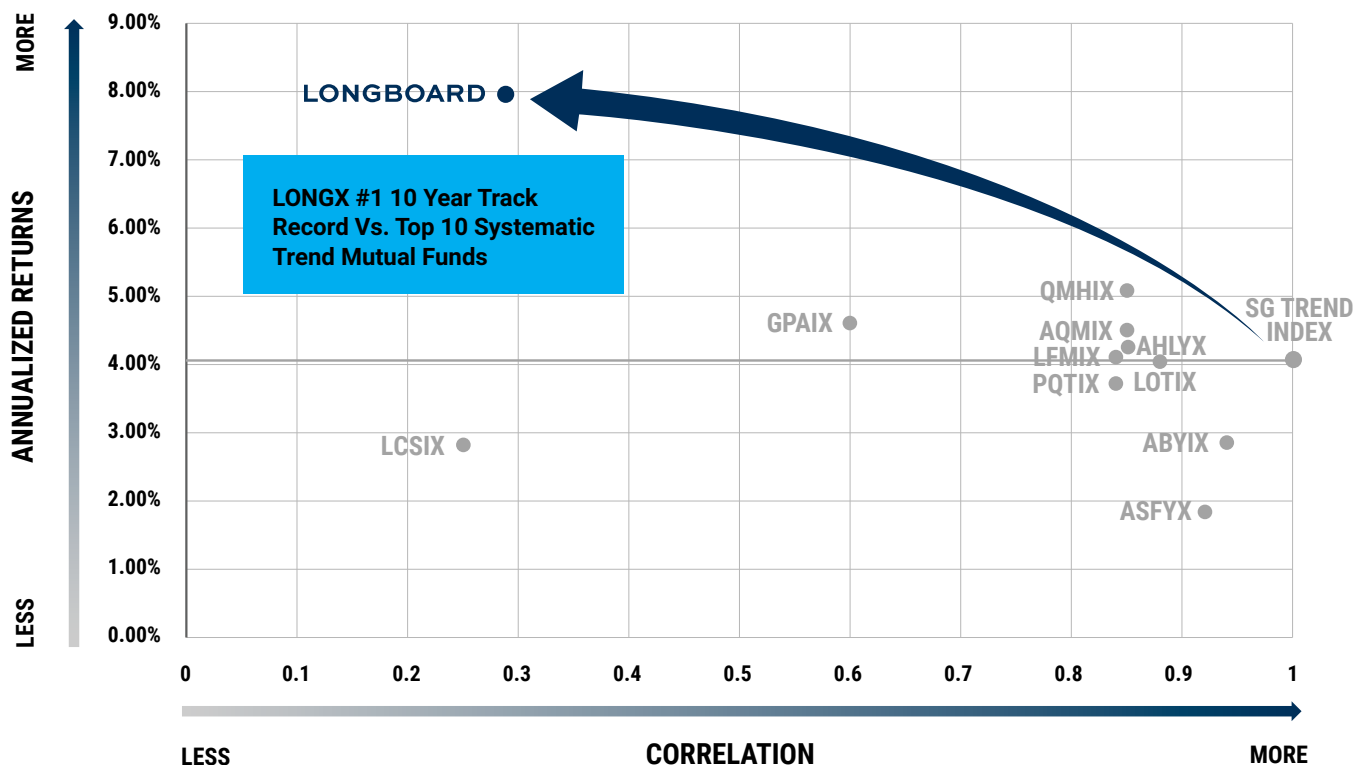

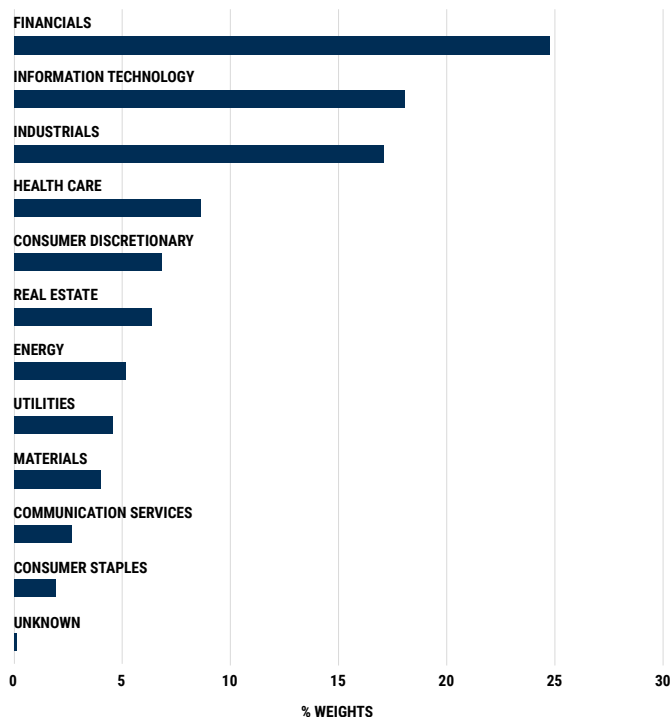

Sector Allocation

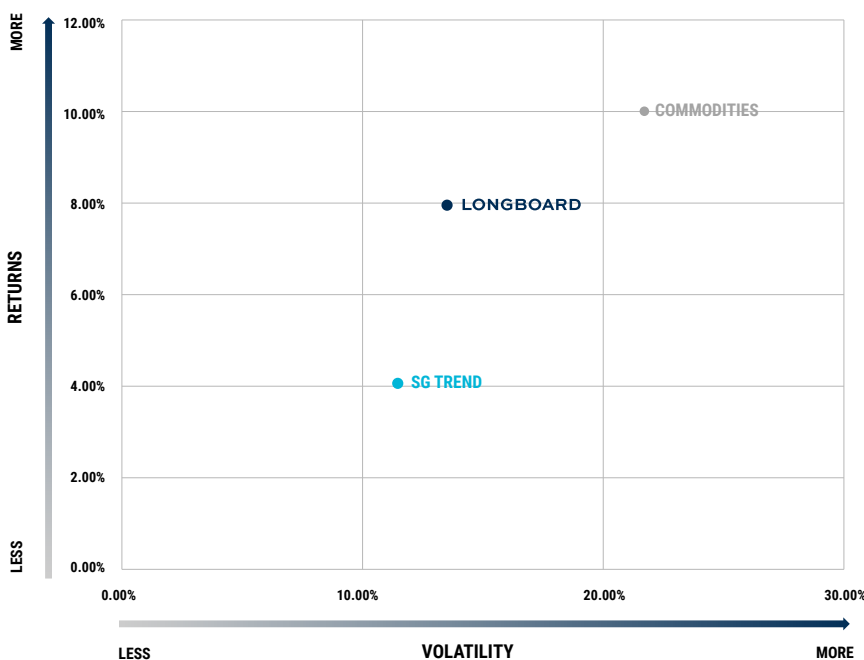

DEFINITIONS

Beta: Measure of the systematic risk of a security or portfolio in comparison to the market as a whole.

CAGR: Compounded Annual Growth Rate, which is the rate of return that would be required for an investment to grow from its beginning balance to its ending balance, assuming the profits were reinvested at the end of each period of the investment's life span.

Correlation: Statistic that measures the degree to which two securities move in relation to each other.

Maximum Drawdown: The maximum loss from a peak to a trough of an investment or portfolio, before a new peak is attained.

Russell 2000 Index: A small-cap stock market index of the smallest 2,000 stocks in the Russell 3000 Index.

S&P 500 TR Index: A stock market index that measures the stock performance of 500 large companies listed on stock exchanges in the United States. It is one of the most commonly followed equity indices, and many consider it to be one of the best representations of the U.S. stock market.

S&P GSCI: Serves as a benchmark for investment in the commodity markets and as a measure of commodity performance over time.

SG Trend Index: Equal-weighted and reconstituted annually. The index calculates the net daily rate of return for a pool of trend following based hedge fund managers.

Sharpe Ratio: Risk-adjusted evaluation of return on an investment, which indicates how well an equity investment is performing compared to a risk-free investment, taking into consideration the additional risk level involved with holding the equity instrument.

Sortino Ratio: Risk-adjusted evaluation of return on an investment that is a variation of the Sharpe Ratio, in that it only factors in downside risk. It is used more to evaluate high-volatility portfolios.

Standard Deviation: A measure of an investment's volatility. Standard Deviation measures how much the investment returns deviate from the mean of the probability distribution of investments (how much the investment will deviate from its expected return). Investors use this metric to help determine an investment or portfolio's annual return by considering its historical volatility.

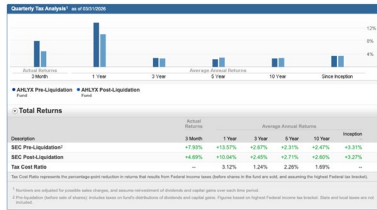
The comparison funds referenced were chosen based on a series of parameters which include a ranking of the top 10 open-ended systematic trend funds as categorized by Morningstar with an inception date prior to 4/1/2015, by assets under management (AUM). The funds used in this comparison are well known systematic trend mutual funds and therefore may be more widely used among financial advisors. Funds under \$100 million in AUM as of 3/31/2026 were filtered out. Like the Longboard Fund, the comparison funds are all open-ended mutual funds with daily liquidity. Regarding the Systematic Trend category: These funds primarily trade liquid global futures, options, swaps, and foreign exchange contracts, both listed and over-the-counter. A majority of these funds follow trend-following, price momentum strategies. Other strategies included in this category are systematic mean-reversion, discretionary global macro strategies, commodity index tracking, and other futures strategies. More than 60% of the fund's exposure is invested through derivative securities. These funds obtain exposure primarily through derivatives; the holdings are largely cash instruments.
