2021 WAS ANOTHER DISRUPTIVE YEAR AS THE COVID-19 PANDEMIC **CONSTRAINED US TO ADJUST AND ADAPT THE ACTIVITIES PLANNED** THROUGHOUT THAT YEAR.

FinanceMalta, as an organisation, made good progress and implemented several initiatives which will have a positive impact on the further development of Malta's financial services sector.

Our long-standing aspiration of increasing Malta's visibility as a financial service centre and enhancing business opportunities for our members is more relevant than ever. The onset of the pandemic in March 2020 forced us to find new ways to stay connected. Digital communication became the norm and remained a key factor throughout the past year. However, 2021 was also a year of many firsts for our organisation.



Podcast Series

The year began with the launch of our first ever podcast series #FinTalks for listeners around the world. #FinTalks features FinanceMalta's members as well as stakeholders operating in the financial services industry. We published a total of 23 episodes during the year. Each episode is available in audio format on the main podcast applications, and the video is uploaded on FinanceMalta's YouTube channel. #FinTalks has been a success story for FinanceMalta with over 1,000 downloads in more than 30 countries.

Founding Member

A highlight of 2021 was that together with ten other organisations from Germany, France, Italy, Luxembourg, the Netherlands, Belgium and Estonia representing EU financial centres and federations, we founded the Roundtable of EU financial centres. which is the EU regional chapter of the World Alliance of International Financial Centres. The Roundtable will promote the creation of a common EU financial market as well as strengthen cooperation and exchange between EU member states. We are committed to working with our EU counterparts by representing the industry with a common voice at a European level and building deeper connections with other international finance centres in the years ahead.

New Platform

Our flagship event, the Annual Conference, was held in a hybrid format once again. We invested in a brand new platform for virtual events which provided a very positive user experience and allowed participants to join from any place in the world. We registered more than 300 delegates. Most sessions took place physically and this facilitated interesting discussions and debates amongst speakers and delegates. Together we looked at the latest developments in the world of FinTech and RegTech and discussed the future of asset management, banking, insurance, and private wealth. Our speakers and panellists also answered questions on cybersecurity, talent development, good governance, and sustainable finance.

Sectorial Initiatives

Later in the year, we issued new sectorial guides to our diverse financial services industry. The "Why Malta" brochures are freely available on our website, and FinanceMalta members can make use of them for their own marketing efforts. Another first is that the publications can be co-branded, and we offer members the opportunity to include their logo alongside ours at no added costs.

After a long pandemic-induced break, we hosted an in-person event in November where we launched the first FinanceMalta sectorial-specific event and discussed the status of the insurance sector. We had been waiting to meet our members in-person for nearly two years, and we felt it was crucial to discuss and debate the current challenges and opportunities particular to this sector. 2022 will see a continuation of this event series.

Member Focus

Our core mission is to bring together Malta's financial industry, and our members are our most important asset. Last year, we significantly ramped up our efforts to ensure our members gain visibility in Malta and abroad. Initiatives ranged from offering them speaking opportunities at international in-person and virtual events to in-depth interviews and Q&As as part of our member spotlight series distributed with our email newsletter and shared on social media.

This is just a short overview of the activities we held last year. We also worked on our website, which has increased its page views by 23.5% when compared to 2020, enhanced our presence and profile on social media, organised webinars on various topics, and attended a total of 12 virtual events and 8 in-person events in various jurisdictions. Looking back at 2021, through our various initiatives, we managed to reach a much larger and more diverse community than we ever did before. Of course, none of this would have been possible without our members. I would like to thank all my colleagues in the financial services sector for their continued support.

Change and Evolution

The past two years have emphasized the need to accept and manage change and unpredictability. We now have before us a new set of challenges, and a new urgency to implement change successfully. There is no doubt that the immediate priority is the removal of Malta's name from the Financial Action Task Force (FATF)'s advanced monitoring list. Malta has strived to achieve this objective at all levels - the industry has raised its standards, the regulators and supervisors have reviewed their systems, while law enforcement agencies have increased their participation, resources and training. This experience has enabled us to turn this challenge into an opportunity for growth and improvement.

As we seek to realise opportunities in the months and years ahead, FinanceMalta will continue to work closely with its members. I encourage all members to consider how they can assist to support the sector moving forward. With the rapid pace of change and disruption we are experiencing today, we all need to work together. As an organisation, FinanceMalta will endeavour to continue evolving, and I am confident that we will successfully advance our strategic direction as the world around us continues to shift.

BOARD OF GOVERNORS



RUDOLPH PSAILA Chairman

Rudolph Psaila is the CEO of AlleyBe Group, an independently owned Group which is engaged in the Corporate, Trust and Fintech Industry.

He started his career working for PwC Malta and PwC in the Channel Islands and during his ten-year career working in Malta and abroad, he had the opportunity to work on international, high profile assignments. He also chairs the Insurance and Pensions sub-committee within the Malta Financial Services Advisory Council.

Kenneth Farrugia joined Bank of Valletta plc (BOV), Malta's largest banking group, in 1985 and has since occupied various positions within the Bank. Kenneth currently holds the post of Chief Retail Banking Officer at Bank of Valletta plc and sits on the Group's Management Board. Kenneth is, amongst others, responsible for the improvement of the Bank's market position, as well as the achievement of financial growth and long-term strategic business goals. Kenneth is also a Governor of FinanceMalta, Malta's national promotional body for financial services, and also serves as Chairman of the MASA. 


FINANCEMALTA MEMBERSHIP TIERS STRUCTURE


PROMOTIONAL STRATEGY

Throughout 2021, FinanceMalta significantly increased its use of digital platforms, and these efforts will be maintained in the future, being that digital presence is a priority for the years to come.




WEBSITE


The following actions were taken to improve the performance of FinanceMalta's website in the course of 2021:

SOCIAL MEDIA

FinanceMalta is present on five social media platforms: LinkedIn, Facebook, Twitter, Instagram, and YouTube.

These channels were used extensively to pursue several objectives, among which:

- 1. Promote Malta as a jurisdiction
- 2. Promote FinanceMalta activities
- 3. Promote FinanceMalta membership
- 4. Give visibility to FinanceMalta members

LinkedIn is the most used platform in the Financial Services industry, both on an international and local level. Twitter is very popular among international players, while Facebook is more widely used in Malta. We use these three social media platforms in similar ways since the target audience is also similar apart from the geographical element.

Posts on these platforms included: #FinTalks shorts; promotion of FinanceMalta initiatives; information on the calls for Expressions of Interests (EOI) issued, FinanceMalta's 2021 Corporate video, sharing of content and events posted by FinanceMalta members on our website; as well as other information pertaining to our members.

Google MyBusiness was added to the marketing mix in 2021. This platform will be used to further improve FinanceMalta's Search Engine Optimisation (SEO) efforts.

DURING 2021, FINANCEMALTA'S YOUTUBE CHANNEL WAS REVITALISED WITH NEW EXCLUSIVE CONTENT. PRIOR TO THIS, THE CHANNEL WAS ONLY USED AS A REPOSITORY OF ALL VIDEOS PUBLISHED BY FINANCEMALTA.

However, during 2021, the videos of the #FinTalks Podcast series were published on our YouTube channel. The number of views and subscribers started to increase at a very stable rate. The channel now has over 310 subscribers, corresponding to a 57.49% increase from 2020.



IMAGE/VIDEO SERIES

During 2021, FinanceMalta posted daily updates on all social media platforms. The aim of creating image/video series is to increase the level of engagement with our followers, boost our organic reach, and create quality content. FinanceMalta retained two image series from the previous year and added four brand new image/video series:

1. #WHYMALTA (IMAGE SERIES)

Promotes the Unique Selling Points of Malta in financial services.

2. #NOTONLYBUSINESS (IMAGE SERIES)

Aims to showcase the quality of the life in Malta. By publishing such posts, the heritage of Malta, its culture and traditions, as well as the activities that one can do outside business hours are promoted.

3. #FINTALKS SHORTS (IMAGE SERIES)

Aims to repurpose our podcast content and highlight key questions asked during the podcasts. The #FinTalks shorts are approximately 5-minute videos posted on our socials.

4. THE STORY BEHIND (IMAGE SERIES)


Posted on public holidays where FinanceMalta gives a historic background to our foreign social media followers on the significance of the holiday towards the history of Malta.

5. VIDEO MESSAGES FROM INTERNATIONAL EVENTS (VIDEO SERIES)

For the return of in-person events during the months of October and November 2021, FinanceMalta posted video updates from international events and gave visibility to the members who participated and represented FinanceMalta. Online engagement and response were very positive and we intend to continue posting video updates when attending foreign events in 2022.

6. FINANCEMALTA FINANCIAL NEWS ROUND-UP (IMAGE SERIES)

During 2021, FinanceMalta launched a new Instagram and Facebook stories series to provide weekly local and international financial news roundups featuring the headlines which had an impact on the financial services industry.



The FinanceMalta social media channels were also used to promote Corporate Social Responsibility (CSR) activities, such as the donation given to the YMCA, as well as to raise awareness on socially relevant topics, such as the importance of screening for early detection of cancer (Pink October), and World Suicide Prevention Day. Furthermore, FinanceMalta's socials were also used to celebrate World Photography Day, World Tourism Day, Human Rights Day and promote national achievements like Project Maleth.







#FINTALKS PODCAST SERIES

The #FinTalks - A chat with FinanceMalta is a podcast series hosted by FinanceMalta and featuring members and stakeholders operating in the financial services industry.

The series has two editions: the "Institutional edition" features representatives from a variety of entities regulating the industry and aims at providing updates on procedures, regulation and new legislation.

The "Members edition" aims at offering the opportunity to FinanceMalta members to address a topic of interest and, at the same time, providing thought leadership on the various sectors. This is offered at no cost to FinanceMalta members and is one of the activities that FinanceMalta has in place to increase visibility to its members.

The first episode was published in March 2021. In total, 23 episodes were published during the year: 13 episodes of the Institutional Edition and 10 episodes of the Members Edition. Each episode is available in audio format on the main podcast applications (six portals in total), while the video is uploaded on FinanceMalta's YouTube channel.

In the first half of the year, FinanceMalta attended a total of 12 virtual events and hosted a webinar in Q1 titled **Banks in Malta**


- Dealing with trusts and foundations. The FinanceMalta Annual Conference was organised in July 2021, and it was held as a hybrid event.

FINANCEMALTA EVENTS

The 14th FinanceMalta Annual Conference | 20-21 July 2021 | Hybrid Malta/Online

The FinanceMalta 14th Annual Conference, held on 20-21 July 2021, was the most important event of the year for FinanceMalta. As it was the case in 2020, the event was held in a hybrid format to ensure the safety of all participants. 
Family Office Forum Zurich | 9-10 November 2021 | Zurich, Switzerland
