# **Assumptions**

Advertising expense calculated at 10% of Product Revenue.

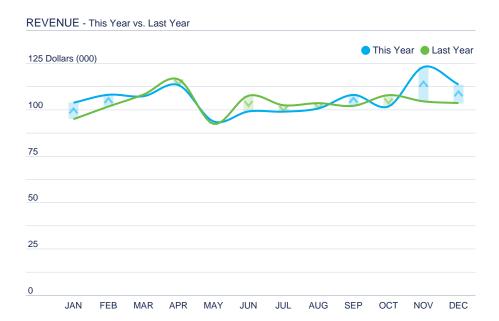

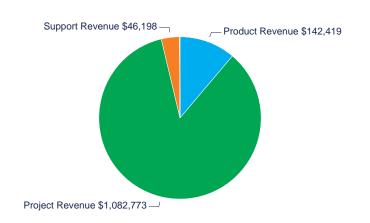

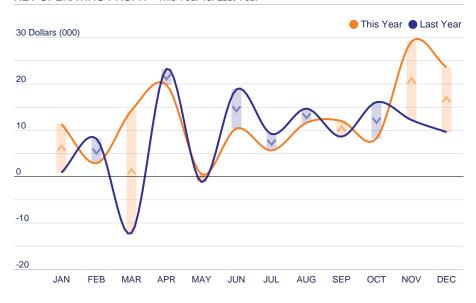
#### TOP REVENUE CONTRIBUTORS



#### REVENUE AND NET OPERATING PROFIT - Last Year and Current Year



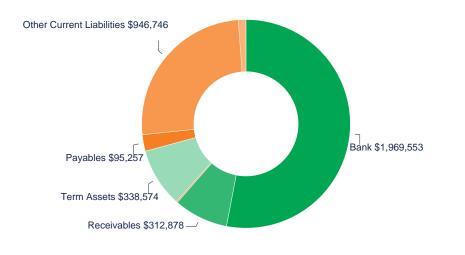
#### NET OPERATING PROFIT - This Year vs. Last Year



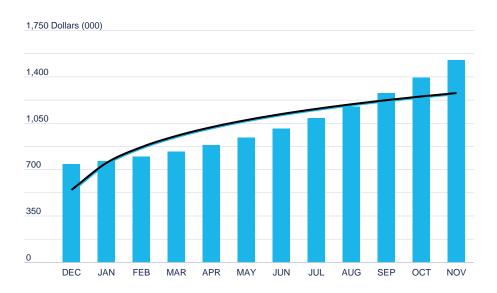

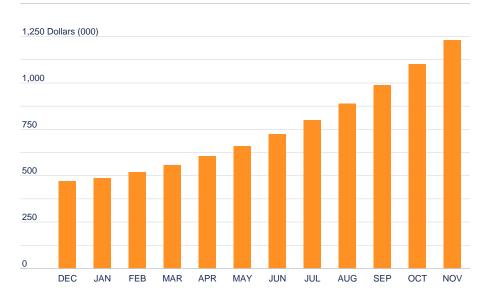

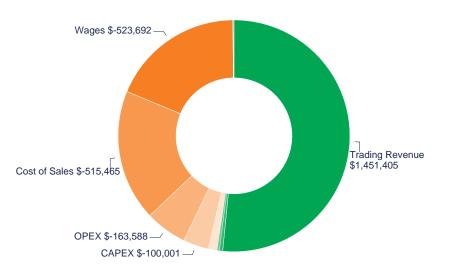

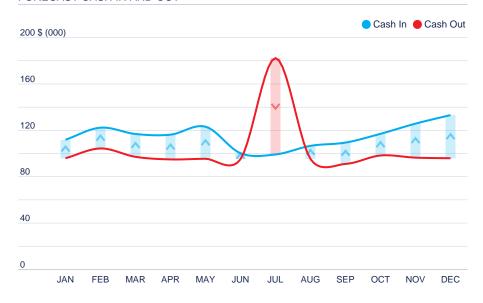
#### CASH ON HAND FORECASTS



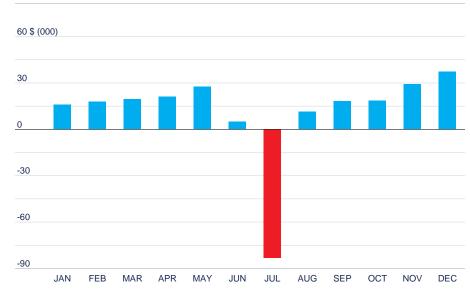
#### FORECASTED CASH FLOW
