## RECITALS

- A. On or around **2 August 2023**, damage was caused to the Releasor's vehicle registration no. **1QC1UN (Event)**.
- B. The parties have now finalised and settled their dispute and wish to release each other from all possible actions and liability in relation to the dispute.

## OPERATIVE PART

- 1. The Releasee will pay to the Releasor the sum of **\$800.00** in full and final settlement of the dispute relating to the Event between them within seven (7) of days of the date of execution of this deed by both parties.
- 2. This Deed of Release (**Deed**) is entered into by the parties without admissions of any kind and with the intention of finalising for all time their rights and obligations arising by virtue of the recited agreement.
- 3. The parties certify that they have the authority and legal capacity to enter into this Deed which they have considered in detail, and the consequences of which they understand, and which they have done freely, having sought such legal and other advice as they deem prudent and necessary.
- 4. The Releasor hereby releases, indemnifies and forever hold harmless the Releasee from all claims, actions, suits, demands, costs, damages, and expenses which it may have had in any way connected with the Event but for the execution of this deed by reason of or arising out of the recited agreement.
- 5. The Releasor acknowledges that this document shall be executed as a deed and may be pleaded as full and complete defence by the Releasee to any claims, actions, suits or proceedings commenced or taken by the Releasor in connection with the Event or any of the matters referred to in this deed.
- 6. The Parties agree that this deed of release contains the full agreement and the entire understanding between the parties and is to remain confidential. This Deed shall be governed by and construed in accordance with the laws of Victoria.
