SUBJECT TO VENUE RULES. ANY ADDITIONAL FEES REQUIRED BY THE NH STATE LIQUOR COMMISSION LIKE POLICE PRESENCE WILL BE THE RESPONSIBILITY OF THE CLIENT.

PLEASE NOTE: IF YOU CHOOSE TO GO WITH KEGGED BEER, IT MUST BE CHILLED DOWN 24 HOURS PRIOR TO SERVICE. ALL KEG TAPS AND TAP HANDLES WILL BE PROVIDED AND TESTED OUT BY THE CLIENT BEFORE SERVICE. CHILL CATERING DOES NOT SERVICE OR FIX FAULTY KEG SYSTEMS DURING SERVICE
