

Vocal Customer 360



Agent analyzes 360 customer view to extract key info & trends for sales rep's upcoming visit and then vocally provides this information to a sales rep

Voice-to-Action



Using a mobile application sales rep explains vocally what he sees, and the system automatically fills in parts of the visit report

Visit Summary & Action Items



Agent analyzes the visit report, survey, order, etc. to extract insights and help refine future visit plans

Menu Data



Parses Menu Data from the websites of the accounts of interest, and prepares report on presence, composition and price of alcoholic beverages & cocktails

Smart Order Assistant

Search Process Automation Bot



Automates the search for mentions of the company or its products in government portals, generating daily reports based on search results.

Master Data Management Bot



Automates the process of creating Master Data entries in ERP based on an Excel file, notifying stakeholders once completed.



Supply Chain and Logistics

Our automation solutions in the Supply Chain and Logistics category streamline inventory management, item creation, work order processing, and replenishment.

By automating data validation and order processes, these bots ensure real-time efficiency, accuracy, and resource availability across various logistical functions.

Inventory Reconciliation Bot



Automates the process of consolidating monthly inventory reconciliation files from SharePoint into a master database, validating data, and updating reports with exceptions highlighted.

PackMaster Item Creation Bot



Automates the creation of new packaging items in ERP based on information from an Excel file received through email.

ShipFlow Order Release Bot



Automates the release and reservation of packaging work orders in ERP by calculating dates and updating orders while ensuring material availability.

Auto Replenishment Bot



Automates replenishment from regional distribution centers to local operating companies by gathering data from SAP systems and creating purchase orders.

CarrierCheck Data Validation Bot



Automates the validation and consolidation of carrier data reports into a template and sends notifications if there are any errors or missing data. CATEGORY:

Supply Chain and Logistics

Supply chain processes often involve **heavy** manual work:

- Multiple suppliers: onboarding, purchase orders, invoicing, shipment tracking
- Logistics partners: scheduling, rerouting, last-minute changes

Al Agents can slash admin overhead by:

- Automating repetitive tasks (fewer emails & manual follow-ups)
- Rapidly responding to disruptions (dynamic supply plan updates)
- Streamlining supplier onboarding & compliance checks

Result: Higher efficiency, faster responses, and fewer surprises.

Automated Purchase Order (PO) Generation



Once inventory levels dip below a threshold, an Al Agent can create and send POs to suppliers without human intervention Autonomous Exception Handling



If a supplier can't fulfill an order, the Agent can reroute to an alternate supplier or propose changes to production schedules Smart Negotiation



Advanced Agents can even propose alternate payment terms or shipping methods based on real-time cost and lead-time analysis

The Agent requests, receives, and evaluates supplier documents, comparing them to internal rules (e.g., ISO certifications, insurance coverage)

If a certification is nearing expiration, the Agent automatically notifies the supplier and sets a deadline for updated documents. If not received, it may escalate internally

Suppliers' Regulatory Updates



The Agent monitors relevant regulatory changes and prompts suppliers for additional compliance steps as needed



Regulatory Compliance and Quality Control

Our automated solutions for Regulatory Compliance and Quality Control help companies adhere to legal and industry standards, by automating the validation, reporting, and tracking of compliance issues.

These bots ensure that promotional materials, product complaints, and regulatory reports meet compliance standards, minimizing risk and manual effort.

Promo Materials Review



Reviews promotional material in Veeva PromoMats, ensuring compliance by performing checks on keywords, disclaimers, and preparing reports for regulatory teams.

Product Complaints Data



Automates the process of transferring product quality complaints from medical information system to the TrackWise system, generating reconciliation numbers, and notifying stakeholders via email.

HCP Compliance Automation



Automates the matching of SAP payment data with transparency reports, ensuring compliance with guidelines for payments to HCPs.




Document Understanding In Route Settlement

What we want to solve?

In the Route Settlement (RS) area, around 3.7m documents are manually settled yearly. This is necessary to ensure each delivery document has a customer signature and no handwritten corrections, making the process time-consuming and prone to errors.

Why?

By identifying and categorizing documents that have the required signatures and no handwritten corrections (estimated to be 80% of the total documents), we can process these for automatic settlement. This automation will save approximately 31k hours per year of manual work.
