

## Update on the Liquidity Agreement

In relation to the liquidity agreement signed with Kepler Cheuvreux, Inclusio announces today that Kepler Cheuvreux on behalf of Inclusio has bought **866 shares** during the period **from 18 May 2026 to 29 May 2026** on Euronext Brussels.
