





SAFETY REPORT

NOVEMBER 2025

On November 1st, at approximately 1000 hours on duty, Captain Fregoso, while patrolling the area of 6th and Broadway, observed a large crowd of Dodgers fans celebrating the Dodgers World Series win and blocking traffic, leading to street takeover. LAPD tactical alert team responded quickly and managed to get the crowds to disperse from the district without any property damage or vandalism. Captain Fregoso along with Historic BID officers maintain continuous surveillance of the district to ensure the safety of the businesses. Captain Fregoso conducted a uniform presence and maintained constant communication with the businesses.

On November 3rd, at approximately 05:30 hours, Officer Gallegos, while patrolling the area of 501 S Broadway, observed the exterior roll-up gate to the business was partially open and the entrance main glass door was completely shattered. Officer Gallegos immediately proceeded to contact the LAPD and further investigate the incident that transpired. After further investigation, Officer Gallegos made contact with the business owner that was currently on site, who stated that he received a burglary alarm activation and, upon arrival, observed the property damage. The owner stated that he immediately contacted the LAPD to file a police report and that he would attempt to obtain CCTV footage to determine the time of the incident. Officer Gallegos remained on site for uniform presence until the LAPD arrived at the scene.

On November 4th, at approximately 0300 hours on duty, Officer Gallegos, while patrolling the area of 437 S Broadway noticed a fire alarm activation (strobe lights & audibles). The residents of the complex had evacuated and were stationed outside the building waiting for LAFD to respond. Officer Gallegos immediately assisted with uniform presence and proceeded to wait for LAFD to further investigate the alarm. LAFD, upon arrival, proceeded to enter the building to determine the cause of the alarm. After further investigation, LAFD determined that the cause of the alarm was a faulty smoke detector. The residents of the building were instructed to return to their units and Officer Gallegos remained on site until LAFD departed, and the area was clear.

On November 9th at approximately 10:30 hours, Sergeant Ajaa, while patrolling the area of 5th and Spring Street, observed an elderly woman who lost consciousness. Sergeant Ajaa immediately proceeded to check for breathing and call emergency services (911), then place the subject in the recovery position, while monitoring closely until help arrives. Sergeant Ajaa observed paramedics arriving on scene and proceeded to flag them down. Upon arrival, paramedics immediately administered first aid and proceeded to transport the subject to the nearby hospital.

On November 26th at approximately 1130, on duty Outreach personnel Guillermo Vazquez was called to a young woman by the security team at 437 S. Broadway. OC Guillermo made contact with the individual (Ms. Jefferson) requesting services in finding some kind of housing/ assistance. Ms. Jefferson has been living out of a tent for the past year, she has a cat with her which makes finding shelter difficult. I was able to make contact with Circle L.A, they arrived within an hour and they were able to set her up in a woman's shelter that could also accommodate pets. LAHSA has a particular program that is shelter/ pet friendly. OC Vazquez collected Ms. Jefferson personal information and Ms. Jefferson went off with the Circle L.A workers for further assistance.

At approximately 1330 hours, outreach coordinator Guillermo Vazquez, while patrolling the area of 7th and Main streets, approached a woman across the street from the Cecil Hotel. OC Vazquez inquired with the subject if she required any housing assistance. Ms "Robins" was from Iowa. She moved out there expecting to work only to find that the job was a fabrication. She had spent what little money she had and had been on the street for the past couple of months. OC Vazquez jotted down her information and is currently working with the organization of PATH to establish housing.

On November 14th, on duty Sergeant Garcia, while patrolling the area of 543 S Broadway, observed various cardboard boxes on the street sidewalk floor, impeding pedestrians from walking. Sergeant Garcia immediately proceeded to make contact with the business owner and address the illegal dumping incident. After further investigation, the owner stated that they do not have a recycling or trash bin to dispose of the empty boxes. Sergeant Garcia instructed the owner to collect the boxes from the sidewalk and to find an alternative to the persistent problem. The owner complied and contacted the city to schedule a trash pick-up for later that week.

On November 27th, at approximately 0600 hours on duty, Sergeant Garcia observed heavy DOT personnel on site cautioning and blocking off various intersections. Sergeant Garcia was informed that there was the annual Turkey Trot run scheduled for later during the day. Sergeant Garcia immediately coordinated with the Historic Core team and proceeded to assist DOT with vehicle traffic control to place the district barricades. The historic BID Officer remained vigilant during the run and assisted the participant with directions as needed to the water stations.
