

Field Response- December 2025



On December 2nd, at approximately 1930 hours, while patrolling the area of 6th and Wall Street on duty, Sergeant Covarrubias observed a trash bin fire that was out of control with flammable items posing a significant risk to property damage. Sergeant Covarrubias immediately called 911 and requested that the LAFD be dispatched to the area. The LAFD responded to the trash bin fire by assessing for potential spread and immediately proceeded to extinguish the fire. Sergeant Covarrubias assisted with securing the area and safely guided people in the area.

On December 6th at approximately 21:30 hours, on duty, bike patrol officer Lopez, while patrolling the area of 855 S Broadway, observed a white BMW driving the wrong way in extremely dangerously. The vehicle came to a complete stop by colliding with a parked vehicle (Red Subaru). Officer Isaac immediately made contact with the driver to ensure his safety. The owner of the parked vehicle was not on site and officer Lopez then proceeded to instruct the driver to contact his insurance and rental company to follow up on the incident. The driver was further instructed to file a police report with the LAPD. The owner of the parked vehicle was later notified of the incident that transpired.

On December 10th, at approximately 13:45 hours, on duty, Officer Lopez, while patrolling the area of 456 S Main Street, observed major LAFD activity in the area. Officer Lopez immediately made contact with responding unit T9, who stated that there was a fire alarm activation that needed to be investigated. Officer Lopez assisted with vehicle and pedestrian traffic control and ensured that all tenants evacuating proceeded to the safe refuge area. After further investigation, the cause of the fire alarm was due to a faulty smoke detector. All tenants were instructed to return to the building and pedestrian traffic resumed to normal.

On December 13th, at approximately 12:30 hours, on duty, bike patrol officer Michael Huezo responded to a call regarding an individual that was in the middle of the street blocking vehicle traffic with a shopping cart. Officer Huezo immediately made contact with the individual and instructed him to gather his personal belongings and depart from the area. Officer Huezo observed that the individual had mental health conditions with disabilities. Officer Huezo proceeded to assist the individual by collecting his items and placing them inside the shopping cart. The subject proceeded to comply with the verbal commands and departed from the area.

On December 14th, at approximately 0400 hours, while patrolling the area of 410 S Los Angeles, on-duty officer Solis observed that the exterior roll-up gate to the business was partially open and accessible for access. Officer Solis further observed that there were various items left behind outside the business and that the exterior glass door to the business was shattered, a possible break-in. Officer Solis immediately contacted the LAPD and requested that a unit to be dispatched to the area to further investigate the incident. LAPD immediately secured the scene and filed an official police report. The LAPD completed their investigation and the owner was contacted.

On December 15th, at approximately 1345 hours, while patrolling the area of 558 S Broadway, on-duty officer Lopez was flagged down regarding an individual having a medical emergency and requesting paramedics. Officer Lopez immediately assesses the situation and evaluated the scene for safety. The subject was complaining of chest tightness, pain and heaviness. The paramedics arrived on scene and, after further evaluation, determined that the subject had an irregular or fast heart rate and needed to be transported to the nearby hospital for further evaluation.

On December 27th, at approximately 01:30 hours on duty, officer Solis received a service call regarding shots fired at 400 S Main Street. Officer Solis immediately instructed the property manager to contact 911 and request immediate assistance. According to the property manager, there was an exterior window that was shattered due to the gunshot, but no physical injuries occurred during the incident. LAPD responded to the call and focused on safety, securing the scene, and gathering evidence. The Historic Core cleaning team members coordinated with the building maintenance unit to attempt to secure the damaged exterior window with plywood. Safety Officers monitor the area for suspicious activity.

On December 28th, at approximately 13:15 hours on duty, Officer Lopez, while patrolling the Farmer's Market, observed an individual that was in the area engaging in unwelcome, offensive, behavior. The subject was insulting and making threats without proper cause. Officer Lopez instructed the subject to depart from the area and that the LAPD would be notified for making threats to hurt others. At approximately 13:30 hours, the LAPD responded to the scene and instructed the subject to depart from the area. The subject gathered his personal belongings and departed West bound on 5th street. Officer Lopez continues to monitor the area for unusual activities.
