Proof of Identity Requirements

Illawarra Pistol Club Inc. uses the prescribed verification procedure (100) point check, pursuant to the Financial Transaction Reports Act 1988, for the purposes of establishing the identity of applicants.

You must establish your identity by providing documents certified by a Justice of the Peace (showing their registered number) as true copies of the original from the list below that add up to a minimum of 100 points.
