Valour Pi (PI) SEK

Introduction

Valour Pi (PI) SEK is an exchange-traded product that tracks the price of PI, the native cryptocurrency of Pi Network. The project was launched in 2019 to make mining accessible via mobile phones and is built on a resource-efficient consensus mechanism. Since February 2025, the network has operated an open mainnet and gained a large global user base. The ecosystem continues to develop with applications and online stores to expand the use of PI in digital transactions.

Valour Pi (PI) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

Calculating the price of Valour's ETPs



We calculate the arithmetic mean price of the underlying asset from several major exchanges¹.



Using market rates, we convert the dollar value of the underlying asset into the product currency.



We deduct an annual management fee daily on a pro rata basis.



We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

¹ The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
