# Valour VeChain (VET) SEK

## Introduction

Valour VeChain (VET) is an exchange-traded product that tracks the price of VET, VeChain’s native cryptocurrency. The network runs on the VeChainThor blockchain, developed for enterprises and used in areas such as supply chain management and product verification. VeChain has two tokens: VET for value and VTHO for transaction fees, providing stable costs. Using Proof-of-Authority, the network is fast, efficient, and energy-saving. With tools like ToolChain, companies can easily adopt blockchain technology.

Valour VeChain (VET) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

### Calculating the price of Valour’s ETPs



We calculate the arithmetic mean price of the underlying asset from several major exchanges<sup>1</sup>.



Using market rates, we convert the dollar value of the underlying asset into the product currency.



We deduct an annual management fee daily on a pro rata basis.



We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

<sup>1</sup> The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
