Valour Pepe (PEPE) SEK

Introduction

Valour Pepe (PEPE) SEK is an exchange-traded product that tracks the price of PEPE, a meme-inspired cryptocurrency that has rapidly grown into one of the most recognizable tokens in the memecoin sector. PEPE is deflationary, built on the Ethereum blockchain as an ERC-20 token and leverages the security and decentralization of the Ethereum network.

Valour Pepe (PEPE) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

Calculating the price of Valour's ETPs



We calculate the arithmetic mean price of the underlying asset from several major exchanges¹.



Using market rates, we convert the dollar value of the underlying asset into the product currency.



We deduct an annual management fee daily on a pro rata basis.



We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

¹ The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
