Valour Ondo (ONDO) SEK

Introduction

Valour Ondo (ONDO) SEK is an exchange-traded product that tracks the price of ONDO, a governance token originally launched as an ERC-20 on Ethereum. It is also available on other networks, such as Mantle and Solana. Ondo Finance is a DeFi platform focused on tokenizing real-world assets (RWA), such as short-term U.S. Treasury bonds, in the form of tokens like USDY and OUSG.

Valour Ondo (ONDO) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

Calculating the price of Valour’s ETPs



We calculate the arithmetic mean price of the underlying asset from several major exchanges<sup>1</sup>.



Using market rates, we convert the dollar value of the underlying asset into the product currency.



We deduct an annual management fee daily on a pro rata basis.



We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

<sup>1</sup> The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
