Introduction

Valour Hyperliquid (HYPE) is an exchange-traded product that tracks the price of HYPE, Hyperliquid's native token. Hyperliquid is a decentralised crypto exchange and fast Layer-1 blockchain. It aims to give users the speed and ease of centralised platforms, while keeping everything transparent on-chain. It offers an on-chain order book, almost instant transactions, and trading in spot, margin, and perpetual futures. The network uses its own HyperBFT system for high speed and low delays, while the HYPE token is used for governance, staking, gas fees, and rewards.

Valour Hyperliquid (HYPE) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

Calculating the price of Valour's ETPs



We calculate the arithmetic mean price of the underlying asset from several major exchanges¹.

Using market rates, we convert the dollar value of the underlying asset into the product currency.

We deduct an annual management fee daily on a pro rata basis.

We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

1 The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
