Introduction

Valour The Graph (GRT) SEK is an exchange-traded product that tracks GRT, the native token of The Graph network. The Graph is a decentralised indexing protocol that makes blockchain data easily accessible through open APIs called subgraphs, enabling developers to build fast and reliable dApps. The network is run by indexers, curators, and delegators, while the GRT token is used for staking, governance, and paying for data queries.

Valour The Graph (GRT) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

Calculating the price of Valour's ETPs





We calculate the arithmetic mean price of the underlying asset from several major exchanges¹.

Using market rates, we convert the dollar value of the underlying asset into the product currency.





We deduct an annual management fee daily on a pro rata basis.

We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

1 The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
