### Calculating the price of Valour Bitcoin Zero SEK







We calculate the average price from the four most liquid exchanges'

Using market rates, we convert the dollar value of BTC (BTC/ USD) into the product currency (SEK)

We a multiplier to set the price of one certificate, making it an affordable unit price

1 The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
