# Valour Sky (SKY) SEK



Valour Sky (SKY) SEK is an exchange-traded product that tracks SKY, the native token of the Sky ecosystem. Sky is a decentralised protocol that makes it easy to earn and participate on-chain. It powers USDS, a yield-bearing stablecoin, and offers non-custodial savings, staking, and governance through Sky.money. Built for transparency and scalability, Sky connects users to real yield and community-driven DeFi in a simple, accessible way.

Valour Sky (SKY) SEK enables investments in this ecosystem in a simple, secure, and practical way, and is available for trading on regulated exchanges through a bank or broker. The product is a structured investment under Swedish law and is traded on Spotlight Stock Market.

#### Calculating the price of Valour's ETPs





We calculate the arithmetic mean price of the underlying asset from several major exchanges<sup>1</sup>.

Using market rates, we convert the dollar value of the underlying asset into the product currency.





We deduct an annual management fee daily on a pro rata basis.

We apply a multiplier to determine the price of one certificate, ensuring it has an affordable unit price.

1 The reference price is set using the average price of the underlying asset in USD from several of the most liquid crypto exchanges. The exchanges used may vary depending on their trading volumes.
