Acceptable Use Policy

Digi Dash Acceptable Use Policy ("AUP")

Last updated: January 01, 2025

This Acceptable Use Policy ("AUP") governs how all end-users ("you", "your") may access and use the Digi Dash platform, websites, mobile applications, APIs, and related services (collectively, the "Services"). By using the Services you agree to comply with this AUP, the Digi Dash Terms of Service ("ToS") or applicable Master Services Agreement ("MSA"), Privacy Policy, and all applicable laws and regulations.

1. Access & Registration

Accurate Information. You must provide true, current, and complete information during registration and keep it updated.

Account Security. You are responsible for safeguarding your account credentials and for all activity occurring under your account.

Authorized Access Only. Accessing or attempting to access the Services by automated, malicious, or unconventional means (e.g., scraping, bots, reverse-engineering) is prohibited.

2. General Acceptable Use

You may use Digi Dash solely for lawful, instructional, training, marketing, or entertainment purposes intended by the platform. You may not:

Disrupt, degrade, or interfere with the Services, servers, or networks.

Copy, reproduce, resell, or commercially exploit any part of the Services or content except as expressly permitted in writing by Digi Dash.

Bypass or breach any security, rate-limit, or authentication mechanism.

Upload, transmit, or develop malicious code, malware, or phishing schemes.

Use the Services to send unsolicited commercial messages (spam), run contests or sweepstakes, or conduct commercial promotions without an executed written agreement with Digi Dash.

3. Content Standards

When posting, uploading, embedding, or otherwise providing any content ("User Content") you must not:

Illegal or Harmful Content – Depict, promote, or facilitate illegal activities, violence, self-harm, or exploitation of minors.

Harassment & Hate – Harass, threaten, defame, or discriminate against individuals or groups based on race, color, religion, gender, gender identity, sexual orientation, national origin, disability, or any protected class.

Sexual or Explicit Material – Post pornography or sexually explicit content. Educational medical content is permitted with appropriate context and audience safeguards.

Intellectual-Property Infringement – Upload material that infringes copyrights, trademarks, patents, trade secrets, or other proprietary rights.

Private & Confidential Information – Share personal data or confidential information without consent.

Misinformation & Fraud – Publish deceptive, fraudulent, or knowingly false information, including health or election misinformation, financial scams, "deepfakes," or impersonations.

Unauthorized Advertising – Link to or promote third-party products or services except where expressly permitted by Digi Dash.

Digi Dash reserves sole discretion to determine whether content violates these standards.

4. Anti-Discrimination Commitment

Digi Dash will not tolerate its Services being used to discriminate, incite hatred, or promote hostility or violence toward any individual or group. Violations may result in immediate suspension or termination without notice.

5. Intellectual Property & Licensing

You retain ownership of User Content you lawfully submit, subject to the license granted to Digi Dash in the ToS.

You may not reverse-engineer or attempt to extract source code or underlying data models.

Except under an executed Exclusive License Agreement, no ownership rights to Digi Dash code, assets, or IP are transferred to you.

6. Moderation, Enforcement & Reporting

Digi Dash may (but is not obligated to) pre-screen, review, or remove any content at its sole discretion.

Violations of this AUP may result in warnings, content removal, feature limits, account suspension, or termination.
