I. CALL TO ORDER

Committee Chair Halphen called the meeting to order at or about 1:00 p.m. See attendance detailed above.

II. MANDATORY FORMS REVISION REVIEW

Commissioner Halphen led a discussion on the review of the updated Mandatory Forms. Revisions to the *Property Disclosure Document* and *Louisiana Residential Agreement to Buy or Sell* form were discussed at the committee's last meeting in August. The committee began with a review of the revisions made to the *Property Disclosure Document*, then moved on to discuss revisions to the *Louisiana Residential Agreement to Buy or Sell* form.

Regarding the *Property Disclosure Document*, the committee decided to make the following additional changes:

- Change verbiage from "built" to "installed" in question 10.
- Add blank space for year installed of "Main Structure" and Other Structures" in question 10.
- Remove "NK" checkbox from question 22.
- Remove duplicate "known defect" or "defect" paragraph from page 3 of document as it currently exists on page 1.
- Remove opening paragraph from Property Disclosure Exemption Form (page 2) as it currently exists on page 1 of document.
- Add "contact information" to question 24b.
- On final page of document, move bolded text to separate paragraph.

Regarding the *Louisiana Residential Agreement to Buy or Sell*, the committee decided to make the following additional changes:

- Update verbiage of Mineral Rights (line 32) to read "Seller reserves mineral rights. Y or N".
- Remove "within three (3) calendar days" from line 68 and add a blank space to represent a negotiable number of calendar days.
- Change verbiage from "terminated" to "terminates" in line 162.
- Change "Seller" to all caps in line 338.
