A. Eligibility:

The SFC+ Bingo 2025, ("Bingo") is open only to US residents and physically present in Hawaii to play free bingo, age eighteen (18) years or older at time of entry. Void where prohibited. All federal, state, and local laws and regulations apply. Employees and representatives of Seafood City Supermarket and affiliated entities ("Sponsor") and of any Administrators identified at the end of these Official Rules, and any of their respective parents, affiliates, subsidiaries, licensees or designees, as well as their immediate family members (herein, defined as spouses, parents/stepparents, siblings, children/stepchildren and each of their respective spouses, regardless of where they reside) and members of their household (whether related or not) are not eligible to participate. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Bingo contest and shall not be subject to appeal.

B. How to Enter:

To enter the SFC + Bingo 2025, visit Seafood City Supermarket in Maui on the day of the event every Tuesday or Thursday between September 2, 2025 – October 7, 2025, at [2:00PM] ("Entry Period"). The Entrant has the following options on how to enter Bingo:

Physically visit the Maui store and fill out an entry form.

It will be necessary to provide your full name, email address, and physical residence address (to confirm residency). Sponsor will be the official timekeeper for Bingo. See below section titled "General" for additional rules regarding entry. C. Rules of Play

- 1. The arrangement of numbers required to be covered on bingo paper in order to win the game and the amount of the prize for each game shall be announced to the players.
- 2. Cards will have numbers on a 5x5 grid.
- 3. Each square contains a number, except for a central "free space" which is automatically marked.
- 4. Common winning patterns include a straight line (horizonal, vertical or diagonal).
- 5. Different cards have unique combinations of numbers.
- 6. Players will be allowed to play with a maximum of two Bingo cards. A third (bonus) card will be given to players who download or show the SFC+ app on their phone before the game begins. Maximum of three (3) cards per player per day.
- 7. Qualification for Grand Finale To participate in the Grand Finale on October 7, 2025, players must have physically visited the Maui store and filled out an entry registration form for Free Bingo between September 2, 2025, and October 7, 2025. The registration will be tracked through an online attendance form.

- 8. A player shall be declared the winner of a game if they have covered all the numbers in the required arrangement.
- 9. At the time a player claims to have won and before a prize is awarded, the numbers covered on the bingo paper in the winning arrangement must be verified by audible call back of the numbers covered on the bingo paper in the immediate presence of a floor attendant.
- 10. After a winner is declared, the caller shall inquire clearly and audibly three times of the players present if there are any other players claiming to be a winner of the present game in play. If there are no other winners, the caller shall declare the game to be closed.
- 11. No claim of a player to have won a game shall be valid if made after the game has been declared closed.
- 12. The caller must announce the number of winner(s) for each game and the prize(s) awarded to the winner(s).
- 13. After a winner(s) is declared, players clear their cards, and a new game begins with a fresh set of numbers.
- 14. In the event the number of a ball is miscalled, the actual number shall be the official number for the game and not the number that was called by mistake. Any claim by a player to have won a bingo using a miscalled number shall not be allowed.
- 15. A handwritten, electronic printed or videotaped record for each bingo game played outlining the order in which numbers were called for each bingo game will be created as the official record. Anyone of the methods above will suffice as the official record.
- 16. In the event of an error in verification of bingo paper, resulting in a game being declared closed, the official record shall be reviewed to identify the numbers previously called, the game shall then be reconstructed, and the game shall continue until a winner is declared.
- 17. If it should be determined that a game has been closed as the result of a miscalled number and there is not a valid winner for the game, the official record shall be reviewed to identify the numbers previously called, the game shall then be reconstructed and the game shall continue until a winner is declared.
- 18. No person under the age of 18 is allowed to play free bingo.
- 19. It is the player's responsibility to yell bingo and be heard by the caller. "BINGO" must be called and heard by the caller prior to the caller announcing the closure of the free bingo game and in order for the bingo game to be valid.
- 20. It is essential to follow all rules and etiquette for a fair and enjoyable game experience for all involved.

H. Privacy Policy/Data Collection:

I. Arbitration of Disputes:

As a condition of participation in the Bingo contest, the entrant acknowledges and expressly agrees that any and all disputes of any nature whatsoever that cannot be amicably resolved with Sponsor shall be subject to binding arbitration in the state of Hawaii pursuant to the then existing commercial arbitration rules of the American Arbitration Association. Any such arbitration proceeding shall be conducted in the individual entrant's name only and not in the form of a class action or other representative action. In regard to any dispute, entrant expressly acknowledges and agrees that by entering the Bingo contest entrant waives all rights, if any, to claim punitive, incidental and/or consequential damages and further waives all rights, if any, to have damages multiplied or increased beyond the prizes that are the subject of the Bingo contest. In any such binding arbitration proceeding, the entrant and Sponsor shall share equally in (1) the arbitration fee required by the American Arbitration Association, (2) the cost of use of the arbitration site, (3) any transcription service requested by the arbitrator(s) and (4) the out of pocket expanses of the arbitrator(s) fees. The parties hereby consent to exclusive jurisdiction and venue of the state and federal courts located in Maui County, Hawaii in any action relating to these Official Rules or the Bingo contest.
