- Physical competitions and activities, Events and use of the Suppliers' facilities are all dangerous recreational activities.
- This document is a risk warning for the purpose of the Civil Liability Act (2003) QLD and Australian Consumer Law.
- Any and all warranties, conditions and guarantees in relation to the competitions and activities, Events and use of Suppliers' facilities which are implied by Australian Consumer Law are excluded to the fullest extent permitted by law.

EQUESTRIAN RULES AND REGULATIONS

To compete, all competitors agree to: competing at their own risk and to Maleny Show Society Inc Terms and Conditions. All competitors to pay a Gate Admission.

1. ENTRY to Ring Events:

- 1.1. Nominations via nominate.com.au Online entries close Tuesday 10pm prior to Show.
- 1.2. Nominations on the day received at the Horse Nomination Office by the Ring, ticket system.
- 1.3. HORSE HEALTH DECLARATIONS and Waivers must be received by Horse Nominations Office prior to entry. Download forms malenyshowssociety.org.au No entry to events until forms have been received.
- 1.4. NO REFUNDS after nominations have closed, except maybe with a VETERINARY CERTIFICATE.

2. Yards and Camping

- 2.1. Yard Bookings and Camping available if pre booked as per our Website. No refunds unless cancellation is received 2 days prior to Show.
- 2.2. All electrical equipment and leads must be tested and tagged to comply with safety regulations.

3. PAYMENT OF PRIZE MONEY

- 3.1. All prize money will be paid from the Maleny Show Office (on the Ivan Hankinson Hill). Prize money must be collected on the days of the Show.

4. Judging:

- 4.1. It will be the Judge's decision what places and prizes are awarded when there is only one competitor in a class. Judges may withhold Champion or First Prize from any Exhibit they consider not of sufficient quality.

5. DISPUTES:

- 5.1. Protests in accordance with Maleny Show Society Terms and Conditions.

6. GENERAL

- 6.1. Maleny Show is conducted under the Rules and Regulations of the Maleny Show Society Inc. and Queensland Ag Shows.
- 6.2. Classes may be combined if insufficient numbers.
- 6.3. Stewards reserve the right to alter any event in the Schedule.
- 6.4. A Judge or Steward may direct any person or horse from the competition ring for unsuitable conduct, by one or both.
- 6.5. Competitors must wear correct attire for their classes. Riders must wear approved riding helmets and riding boots
- 6.6. No ring shall be required to wait for any competitor who may be competing in another ring or who is running late into the ring.
- 6.7. If in the opinion of the Judge, any horse or pony is entered in the wrong class, the Judge shall have the power to classify it into the correct class.

7. LEDS

- 7.1. All entries must be registered with a Breed or Registered Society or recorded in accordance with

the rules of the respective Breed Society. Registration papers must be presented if required.

- 7.2. The age of a horse shall be calculated from 1st August in the year in which it is foaled.
- 7.3. ALL COLTS AND STALLIONS, two years old and over must be led in a bit.
- 7.4. The handler/rider of a colt or stallion must have attained the age of 18 years on the day of the show.
- 7.5. All Led classes will be completed before the Ridden classes are judged.
- 7.6. All 1st place winners from Led events are eligible for Grand Champion Stallion, Mare or Gelding of the Show.
- 7.7. SUPREME LED shall be judged after all Led classes are completed.

8. HACKS and RIDER CLASSES

- 8.1. Competitors are advised that riders in Hack, Galloway and Pony Classes can only ride one horse in each event.
- 8.2. LOCAL signifies residency by horse and rider of **Post Codes 4550, 4551, 4552, 4553, 4517, 4518, 4519**. Verification of residency will be required if requested.
- 8.3. DISTRICT signifies residency by horse and rider of Sunshine Coast Council area. Verification of residency will be required if requested.
- 8.4. MAIDEN is a horse that has not won a First Prize in a similar contest at an Agricultural Show.
- 8.5. NOVICE is a horse or pony that has never won an Open Championship in a similar contest at an Agricultural Show.
- 8.6. INTERMEDIATE is a horse that has never won 1st at a Royal Show.
- 8.7. Galloway hacks are over 14 hands and not exceeding 15 hands.
- 8.8. Show Pony Hack and Show Pony Hunter Hack over hands and not exceeding 14 hands may be ridden by a juvenile or adult.
- 8.9. Small Show Pony Hacks and Show Hunter Pony Hack, 12.2 hands and under are to be ridden by a juvenile under 17 years of age.
- 8.10. Horses may be entered in Hack Classes or Hunter Hack Classes but not in both.
- 8.11. Open Hacks may not compete in Show Hunter Classes.
- 8.12. Stallions are not permitted in Hack Classes.

9. MINIATURES

- 9.1. To be registered with any Miniature Horse Society.

10. SHOW JUMPING

- 10.1. OFFICIAL Show Jumping ring under EFA rules and registration.
- 10.2. UNOFFICIAL Show Jumping ring: A HORSE may only compete in any one ring, not both, per day, not including the Six Bar Events. A RIDER may ride in both Unofficial and Official Rings.
- 10.3. Unofficial Ring: Rider and Horse combination may compete in any 3 classes per day
- 10.4. A Junior Rider may compete in both junior and open competitions providing they are members of EFA.

TERMS AND CONDITIONS

FOR THE CONDUCT OF COMPETITIONS AT QCAS AFFILIATED QUEENSLAND AGRICULTURAL SHOWS.

Subject to the Rules, By-Laws and Regulations of the Queensland Chamber of Agricultural Society's Inc. (QCAS) and the Society relevant to this schedule, the following General Regulations shall apply. Where there is a conflict between these regulations and the regulations and rules of the local Agricultural Society, the rules of the Affiliated Agricultural Society prevail.

1. GENERAL REGULATIONS AND ACCEPTANCE OF ENTRIES

- 1.1. All affiliated Queensland agricultural shows are conducted subject to the rules of the Queensland Chamber of Agricultural Societies Inc (QCAS), the constitution and rules of this Society, and any other special regulations which appear within the schedule.
- 1.2. Affiliated agricultural societies may, as required, supplement these regulations with their own special regulations ensuring they are consistent with QCAS regulations.
- 1.3. The attention of Exhibitors is drawn to the fact that entries are accepted subject to the Rules, By-Laws and Regulations of QCAS and the society relevant to this schedule, in addition to any special regulations which appear in this schedule. Copies of the Rules and By-Laws may be obtained upon application to QCAS or the society relevant to this schedule.
- 1.4. No refunds will be made after close of entry.
- 1.5. Prize money must be collected on the days of the show. The society will not take responsibility for any Pavilion entries not collected by the specified dates in the entry pack and schedule.

2. JUDGING

- 2.1. Judging will be performed by a Judge or panel of Judges appointed by the Society.
- 2.2. In the event of the Judge deciding that the exhibits in any Class are not worthy of a prize, no prize will be awarded.
- 2.3. It is considered good ethics that if a Junior Judge or Associate Judge has been judging in his/her own right at any affiliated Agricultural Show, they are not eligible to enter the Young Judges competition at that Show, BUT they can still enter at another Show where they are not acting in a judging roll.
- 2.4. No Exhibitor or members of the Exhibitor's immediate family or employed by the Exhibitor shall approach a Judge with regard to a decision made by the Judge unless they first obtain permission from the Committee person in charge or Steward of the Section.

3. NOTICE TO INTENDING EXHIBITORS

- 3.1. No person under disqualification recognised by the Society may exhibit or compete.
- 3.2. Entries for the upcoming Agricultural Show relevant to this schedule can be made as described for each section in the schedule. Entries submitted other than on the correct form or online will be returned to the Exhibitor and, unless all requirements are complied

with, and the forms returned to the Agricultural Society office by completion of business on the closing date, as shown in this Schedule, they will not be considered.

- 3.3. Notwithstanding the provisions of General Regulation 3.2 above, late entries may be accepted at the discretion of the Section Chief Steward.
- 3.4. Entries are accepted subject to the Rules, By-Laws and Regulations of the Society, in addition to any Special Regulations, which appear in the Schedule.
- 3.5. Exhibitors whose entries have not been accepted shall be advised accordingly and entry fees refunded.
- 3.6. The exhibitor irrevocably consents to the Society publishing or reproducing in any manner whatsoever any particulars or information in relation to their exhibits; the publication or reproduction may be in a printed form or visual image through electronic means and/or on the Internet.
- 3.7. Whilst all reasonable care is taken, the affiliated Agricultural Society cannot accept any responsibility for any losses and/or damage or injury to or by any livestock exhibits, equipment, vehicles or any other property or person whilst on the Show ground's.
- 3.8. Any persons causing a nuisance by loud comments, or the decision of the Judges or of otherwise unseemly behaviour will after being cautioned, be expelled from the show grounds, and in the case of exhibitors, be liable for disqualification.

4. BIOSECURITY

- 4.1. All QCAS affiliated agricultural societies have developed a comprehensive Agricultural Show Biosecurity Plan and all event organisers, competitors and spectators have a joint responsibility to ensure the successful implementation of a biosecurity plan.

5. PRIVACY STATEMENT

- 5.1. The information provided by exhibitors is used by QCAS and the society relevant to this schedule to organise, process and conduct competitions at the relevant agricultural show, sub chamber and state finals. By entering such competitions you consent to their personal information being used for this purpose including this information being made available to sponsors, breed associations, the media, the public, promotional purposes, archival purposes, published in publications and could be made available to other third parties for the purpose of promoting the Queensland agricultural show movement, or as otherwise required by law.

6. WORKPLACE HEALTH AND SAFETY

- 6.1. All QCAS affiliated society's show ground's are designated workplaces within the meaning of the Workplace Health and Safety Act 2011 and exhibitors / competitors are required to ensure that they and all persons under their direction or control, including their contractors or sub-contractors, comply with all requirements of the Act and QCAS holds each exhibitor responsible to discharge its obligations to provide and maintain a safe place and system of work

- during occupation by the exhibitor/competitor of any area of the affiliated Agricultural Society's Show ground's.
- 6.2. Each exhibitor/competitor will assess the risk to themselves, staff, family, volunteers, other exhibitors, agricultural society staff, show visitors, children and any person foresee ably affected by the presentation of their exhibit.
 - 6.3. Risks identified by exhibitors/competitors will be eliminated or controlled by the exhibitor/competitor and particular attention will be paid to ensuring public safety and safety of other exhibitors/competitors.
 - 6.4. Exhibits will only be held & handled by competent persons whose experience is known to the Exhibitor/Competitor.
 - 6.5. Exhibitors/competitors are advised that the use of primus stoves, any heating or lighting appliances of a like character, or any naked light, is strictly prohibited in pavilions or any other building or area defined by the Queensland Fire and Rescue Service.
 - 6.6. Any exhibitors/competitors intending to bring electrical equipment to the Show ground's will be required to ensure that such equipment is fitted with earth leakage circuit breakers / residual current protection and that all electrical leads, tools and appliances have been inspected by a licensed electrical contractor and currently tagged. This is essential for the safety of all exhibitors and the general public AND is a requirement of the current Electrical Safety Regulations.
 - 6.7. The use of double adaptors is prohibited and all power boards must also be tested and tagged.
 - 6.8. All exhibitors/competitors will comply with the requirements of the Act and its Regulations and Standards in every other respect. This is essential for the safety of all exhibitors / competitors and the general public. The Act imposes very severe penalties in the event of noncompliance with its provisions. Any exhibitors/ competitors who do not comply will not be allowed to exhibit at QCAS affiliated Shows.
- 7. DISCLAIMER**
- 7.1. The information contained in the Competitions Schedule/Catalogue is gathered for the purpose of providing information to Exhibitors and show patrons. The information is a compilation of information provided by third parties and QCAS and affiliated Agricultural Society's does not warrant its accuracy and advises that any such information may be subject to change or amendment occurring at any time and thereby making the information incorrect. - 8. GOODS AND SERVICES TAX (GST)**
- 8.1. The Australian Taxation Office has deemed that GST is payable on prizes if an Exhibitor is registered for GST and enters an Exhibit as part of a business enterprise.
 - 8.2. The information an Exhibitor provides on the Application for Entry determines whether GST is applicable.
 - 8.3. Any prize stated in this Schedule does not include GST.
 - 8.4. GST will not apply:
 - 8.5. If an Exhibitor enters an Exhibit as a hobby or private recreational pursuit; or
 - 8.6. If an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, but the Exhibitor is NOT REGISTERED for GST.
 - 8.7. If an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor is not entitled to an ABN as the business or enterprise is not operating in Australia.
 - 8.8. GST will apply if an Exhibitor enters an Exhibit as part of a business enterprise, the Exhibitor has an ABN, and the Exhibitor is REGISTERED for GST.
 - 8.9. Where GST applies, the Society will pay the prize money quoted in this Schedule plus 10% GST. The Society will issue a recipient created tax invoice.
- 9. PROTESTS**
- 9.1. A protest against a Judge's Award must:-
 - 9.2. be in writing addressed to the Secretary, and signed by the person lodging the protest;
 - 9.3. be lodged by delivery to the Secretary's Office within twenty-four hours of the making of the Award;
 - 9.4. give the name and address of the person lodging the protest, and where two or more persons join in the protest, state which one of those persons is authorised to receive correspondence or notices on behalf of all;
 - 9.5. set out in reasonable detail particulars of the matter complained of including but not necessarily limited to the number of the Class and the Award protested against;
 - 9.6. be accompanied by a deposit of \$50.
- 10. PENALTIES**
- 10.1. If the Disciplinary Committee considers that there has been a breach of the rules, By-laws or regulations of the Society, it may impose such a penalty as it considers to be appropriate, including without limitation:
 - 10.1.1. a reprimand;
 - 10.1.2. a monetary fine (payable at such time/s as the Disciplinary Committee may determine);
 - 10.1.3. withdrawal or withholding of any award or ribbon;
 - 10.1.4. disqualification in respect of any class;
 - 10.1.5. expulsion from the Show ground;
 - 10.1.6. where the person concerned is a member, a suspension or termination of that membership;
 - 10.1.7. a ban;
 - 10.1.8. exclusion;
 - 10.1.9. prohibiting a Person from exhibiting or competing at the current Show or at any future Show ;
 - 10.1.10. a direction that an Exhibit be removed from the Show ground;
 - 10.1.11. any other mandatory requirement; and
 - 10.1.12. any other penalty provided for in other regulations of the Society.
 - 10.2. There shall be no appeal from any decision of the Disciplinary Committee.
 - 10.3. The Association may publish to:
 - 10.3.1. all Agricultural Societies in Queensland;

- 10.3.2. the Queensland Chamber of Agricultural Societies
- 10.3.3. the relevant Breed Societies;
- 10.3.4. the body with which the exhibit is registered, or is eligible for registration;
- 10.3.5. the result of any proceedings before the Disciplinary
- 10.4. Committee in which a person has been found guilty of a breach of any Rule, By-Law or Regulation.
- 10.5. The Society shall have no liability to any person in respect of any publication referred to above
- 10.6. No person shall have any claim against the Society or against any Committee member, employee, volunteer or agent of the Society in respect of any act, matter or thing done in good faith during or in connection with the proceedings before the Disciplinary Committee.
