Responsibilities

- Collaborate with the Senior HSEQ Advisor, and relevant directors to develop HSEQ targets, objectives, and strategies.
- Ensure Zest's compliance with HSEQ legislation and industry best practice through expert knowledge and oversight.
- Support the implementation of the HSEQ Management System across all business functions to ensure compliance and maintenance of ISO certifications such as 9001, 14001, and 45001.
- Drive continuous improvement by encouraging & supporting the identification of opportunities for improvement across all business functions and working collaboratively with other departments to address recommendations.

- Develop and maintain effective working relationships with all stakeholders, including employees, clients & contractors, providing support & guidance as required.
- Monitor & measure objectives, targets & safety performance proactively via audits & site visits and communicate performance through scheduled meetings.
- Visit sites to support safe working practices and help resolve any issues alongside operational teams and contractors.
