## **CERTIFIED TRUE COPY OF THE RESOLUTION PASSED AT THE MEETING OF BOARD OF DIRECTORS OF DEV ACCELERATOR LIMITED (FORMERLY KNOWN AS DEV ACCELERATOR PRIVATE LIMITED) HELD ON TUESDAY, 02<sup>ND</sup> SEPTEMBER, 2025 THROUGH VIDEO CONFERENCE**

### **RE: APPROVAL AND ADOPTION OF THE RED HERRING PROSPECTUS IN RELATION TO THE INITIAL PUBLIC OFFER BY THE COMPANY**

The Board took note that the Company, in response to the draft red herring prospectus dated March 30, 2025 (the “DRHP”) filed by the Company with the Securities and Exchange Board of India (the “SEBI”), has received the final SEBI observation letter bearing reference no. SEBI/HO/CFD/RAC-DIL1/P/OW/2025/16909/1 dated June 25, 2025 from the SEBI, which contained its observations and requests for inclusion of further details in the red herring prospectus to be filed by the Company with the Registrar of Companies, Gujarat at Ahmedabad (the “RoC”), BSE Limited and National Stock Exchange of India Limited (together with BSE Limited, the “Stock Exchanges”) or any other regulatory authorities. The updated draft red herring prospectus, after incorporating the necessary updates and changes and after providing such additional information in the document as advised by SEBI, was filed with the SEBI on August 02, 2025 and SEBI noted the changes and provided their approval on August 13, 2025.

The Board approved the same and passed the following resolutions:

**“RESOLVED THAT** in furtherance of the resolution of the Board dated August 01, 2025 approving filing of the updated DRHP, the in-principle approval received from BSE Limited and National Stock Exchange of India Limited both dated April 29, 2025 and subject to and in accordance with the applicable provisions of the Companies Act, 2013, and the rules made thereunder, as amended, the applicable provisions of the SEBI Act, 1992, as amended, the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (“SEBI ICDR Regulations”), the Securities Contracts (Regulations) Rules, 1957, as amended and other regulations issued by the SEBI, the red herring prospectus (the “RHP”), in respect of the initial public offer of equity shares of face value of ₹ 2 each (the “Equity Shares”) comprising a fresh issue of up to 23,500,000 Equity Shares by the Company, at such price as may be determined in accordance with the book building process under the SEBI ICDR Regulations and as agreed to by the Company, in consultation with the book running lead manager to the Issue (“BRLM”), within the price band to be decided by the Company in consultation with the BRLM, as placed before the Board and containing the requisite information as prescribed by applicable laws and regulations, be and is hereby approved for filing with the RoC (pursuant to Section 32 of the Companies Act, 2013 and the rules made thereunder, each as amended), the SEBI, the Stock Exchanges and such other authorities or persons as may be required under the applicable laws.

**RESOLVED FURTHER THAT** any of the directors be and are hereby severally authorised to make any further or subsequent alterations, additions, omissions, variations, amendments or corrections to the RHP and/or to the Preliminary International Wrap, if any, and to finalise the RHP and to file the same with the RoC, and thereafter submit to SEBI, the Stock Exchanges and such other authorities or persons as may be required, issue such certificates and confirmations as may be required and undertake such other necessary steps to implement the above resolution.

**RESOLVED FURTHER THAT** each of the Directors of the Company and the Joint chief financial officers of the Company be and are hereby severally authorized to sign the RHP for and on behalf of the Company.
