AffordableHousing.com, based in Florida, has partnered with the 20 participating housing authorities on the Maine Section 8 Centralized Waiting List and manages the update and reinstatement process on their behalf.

The Request for Reinstatement Form must be complete with supporting documentation, if necessary. The request will then be reviewed and a written decision will be sent back within 30 calendar days of the review.

Please note, per housing authority policy, applicants who are approved for reinstatement to the Maine Section 8 Centralized Waiting List will retain their original date and time of application when returned to the waiting list. However, reinstated applications will not impact the position of applicants that are "In Process" (have been selected for a voucher from the waiting list) at a participating PHA as of the date of reinstatement shall have priority for funding over the reinstated application.

Right to Reasonable Accommodation and Rights pertaining to VAWA- A person with a disability who is applying for assistance under the Section 8 Housing Choice Voucher Program has the right to a reasonable accommodation under the Federal Fair Housing Act, Section 504 of the Rehabilitation Act of 1973, the Americans with Disabilities Act and the Maine Human Rights Act. A reasonable accommodation is a change or exception (waiver) to a rule, policy, procedure, practice, or service that may be necessary for a person with a disability to have an equal opportunity to use and enjoy housing or housing assistance under the Program. 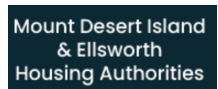
