Solis in the United States District Court for the Northern District of Texas, Dennis has tried cases in state and federal courts throughout Texas and beyond. He has briefed and argued appeals in Texas appellate courts as well as the Fifth Circuit and the Eighth Circuit. Dennis handles lawsuits from the start of litigation through the entire appellate process.
