The CLUB is not and shall not be responsible for any injury, damage, or loss by a member, or his/her family, or guest on or off the CLUB premises while participating in any club activity, even if such losses caused by the acts or omissions of other members, staff, or any other person.
- 3. To pay monthly dues, annual fees, and charges for goods and services upon receipt of a CLUB's monthly invoice via Automatic Debit on your credit card or ACH provided. The dues shall be initially that amount indicated below but shall be subject to increases pursuant to inflation rates and ownership discretion.
