Appendix A

Principal's Report

FSA Meeting: February 2025

1. ATAR results: We have written to our community about this previously and so I will not summarise our results here. I would like to note, though, that we are very pleased with the results, and we are very proud of all that our Class of 2024 achieved across the diversity of our pathways. Having two of the 18 perfect scores across WA is something of which we are also proud, but nothing makes us prouder than the words quoted in the newspaper of one of our 99.95 students, Senuka, about the importance of kindness!

- II. A smooth start to the year: The College and TSS were pleased to have smooth starts to the new academic year, despite some challenges, and I would like to acknowledge here the wonderful work of our staff, and the support of our parents and families, in this. We are delighted to begin the year with 1 306 students at ASC and 109 at TSS, along with very strong numbers in our new childcare, Little Saints.
- III. Evacuation: We evacuated the campus in January due to the proximity of a bushfire. While the fire was several hundred metres away, accurate and consistent information about the status of the fire was difficult to get hence the decision to leave the campus. There was also a degree of anxiety amongst those on campus, with thick smoke and ash on our site, and low-flying water bombing helicopters sounding sirens above us. Our much-practised systems worked well and I was particularly impressed by the efficiency and calm of our Little Saints (LS) staff. We evacuated initially on to the oval this included Admin, Facilities and Parish staff, OSHC, LS, a soccer workshop in the ISC and academic workshops in Building 8 and then returned to work, before making the decision to leave the campus entirely.
- IV. Intruders on campus: The College had five intruders on campus in January. While our Caretaker interrupted their first foray on to campus, the youths returned later that night. CCTV coverage provided sufficiently clear images that we decided to post the photos and the number plates of cars in the carpark on social media. The response was very positive. Fremantle Police subsequently interviewed three males and two females, with one 18-year-old male arrested. He will appear in court in the coming months. The intrusion has been costly, with damage caused by the fire extinguishers released in classrooms, keys / locks needing replacement etc, and our hope is that the Court will require the family to contribute towards restitution.
- V. **2025 theme:** Each year, the College creates a theme around which we unite our community. In 2025, our theme *Words matter. Actions matter more* reminds us to be people of our word, to live our values and commitments. We hope the Old Saints might also be able to make reference to this theme on occasion
- VI. **An interfaith strategy:** Saddened by recent anti-Semitic attacks in our nation and city, and keen that we live our words about inclusion and diversity, I reached out recently to the Principal of Carmel Jewish College, offering to their community our support, and suggesting our students join together to create an interfaith forum: Gen Z unites the world! I wrote also to the local Islamic College who are supportive of the idea, and to our Archbishop, suggesting to her that the faith leaders might like to show their support for such an initiative. I am delighted to report that she is keen to be part of such an initiative and I hope to report further on this initiative in the coming months.
