Membership Fees

- One-Time Initiation Fee (Non-Refundable): \$3,500.00

 - Unused targets roll over month to month
 - Maximum of 4,000 clays on the account
 - A golf cart that may be used for up to 3 hours.
 - Discount on shells

Rules & Policies

- **Check-In Required:**
 - All members and guests must check in at the office before accessing the course
- **Waivers:**
 - All guests must sign a release waiver on each visit
 - All authorized members must have a waiver on file
- **Family Inclusion:**
 - Membership includes spouse/partner
 - Dependent children living at home under 23 years of age.
 - Children must still be living at home and unmarried
 - Please review youth policies for children under the age of 18
- **Lost replacement clay card fee: \$150.00**
- **Clay Targets:**
 - Additional clays can be purchased for .30
- **Sporting Clay Courses:**
 - You have access to come year-round except for the 5 Holidays that we are closed
 - You are welcome to shoot starting at 8 am but must be off the courses 30 minutes before dark.
 - You are welcome to bring as many guests as you would like. We do not charge a guest fee.
- **Communication:**

- Always call or email ahead to inform us of your visit
 - This helps ensure:
 - Carts are available
 - The course is open
 - We are not hosting an NSCA Tournament
 - Notices are sent via **Mailchimp** — contact the office if you're not receiving emails
 - All listed members over the age of 18 should be subscribed to email notifications
 - **Cancellation Policy:**
 - Requires 30-day written notice
 - Club clay card must be returned
 - Unused clays are forfeited upon cancellation and cannot be transferred
 - Billing continues until the card is returned
 - **Fishing**
 - We do not have fishing ponds available for our club members.
 - **Pet Policy:**
 - All animals, whether service animals or otherwise—must remain on a leash and be kenneled outdoors when not under direct supervision. Pets are not allowed inside any Covey Rise Lodge Facility.
 - **Golf Carts:**
 - Carts hold up to 4 people
 - Use for up to 3 hours
 - First come, first serve basis
 - \$50 fee for an additional cart
 - Carts can be reserved for \$20
 - No-shows will still be charged the rental fee
 - Carts are only held 30 minutes past reserved time
 - Cart drivers must be 16+ with a valid driver's license
 - **No children** allowed to operate carts
 - Carts must be returned to the office before visiting The Wesley
 - 4-wheelers are not allowed on property
 - No carts or vehicles of any kind are not allowed to drive or be around the lake near the cabins

Covey Rise Lodge Assumption of Risk and Release Waiver
PLEASE READ CAREFULLY. THIS IS A RELEASE OF LIABILITY AND RELEASE WAIVER.

1. Acknowledgment of Risk

I understand that participation in activities at Covey Rise Lodge, including but not limited to bird hunting, sporting clays, skeet, trap shooting, and use of firearms, involves serious risks, including but not limited to permanent injury, paralysis, and death. While personal skill, equipment, and discipline may reduce these risks, the danger of serious injury still exists for both participants and bystanders.

2. Alcohol and Firearm Use Policy

I acknowledge that **no alcohol consumption is permitted before or while using firearms** on Covey Rise Lodge property. If I am found to have consumed or be in possession of alcohol while using any type of firearm, I understand that I will be asked to leave the premises immediately.

3. Hearing and Eye Protection

I understand that serious hearing loss and eye damage may result from being in proximity to discharging firearms. I acknowledge that Covey Rise Lodge has **advised the use of proper hearing and eye protection**, and that such protection is available for purchase in the pro shop.

4. Assumption of Risk

I knowingly and freely **ASSUME ALL RISKS**, both known and unknown, including those that may arise from the negligence of others. This includes risks caused by any owner, employee, guest, invitee, licensee, member, independent contractor, trespasser, or agent. I accept full responsibility for my participation.

5. Golf Cart Use

All golf carts are operated **AT MY OWN RISK**. Operators must be **18 years of age or older**, unless accompanied by an adult. I understand that all liability rests with the operator or responsible adult. **Children are not permitted to operate Covey Rise Lodge carts.**

6. Medical Condition

I hereby certify that I do not have any pre-existing medical conditions that could be aggravated by activities at Covey Rise Lodge.

7. Minor Participation

I agree that this release also applies to any **minor children participating with me** in bird hunting or sporting clay activities.

• Acknowledgment of Waiver and Release

I have carefully read and fully understand the contents of this waiver and release. I am aware that by signing this document, I am **waving valuable legal rights**, including the right to sue. I release and hold harmless Covey Rise Lodge, their owners, employees, independent contractors, volunteers, agents, and affiliated organizations from any liability for injury, death, or damage that may occur while participating in or observing any activities on the premises.

Covey Rise Lodge – Youth Access Policy

To ensure the safety of all guests and preserve the integrity of our shooting facilities, Covey Rise Lodge has established the following policy regarding **youth access** to the property and shooting areas:

General Policy

Youth under the age of 18 are not permitted unsupervised access to any Covey Rise shooting facility. This includes:

- Sporting clay courses
 - 5-Stand
- Skeet/Trap fields

To participate in these activities without a parent or guardian present, individuals must be 18 years of age or older, unless they meet the specific exceptions below.

Exceptions – Youth Ages 16–18

Youth aged 16 - 18 may be permitted unsupervised access to the shooting facilities under the following conditions:

1. Hunter's Safety Certification Required
 - A valid Hunter's Safety Certification must be submitted and kept on file with the Covey Rise Gun Club Office.
2. Pre-Scheduled Visit Required
 - A parent or guardian must call ahead to schedule the youth's arrival.
 - This allows a Covey Rise staff member to be present and ensure gun safety protocols are followed.
3. No Guests Under 24
 - Youth members may not bring guests under the age of 24 while visiting unsupervised.

Supervision Requirement for All Minors

- All minors on Covey Rise property—whether shooting or not—must be always supervised by a parent or legal guardian, unless they meet the above exceptions. These rules are in place to prioritize safety, responsibility, and respect for all members and guests.
