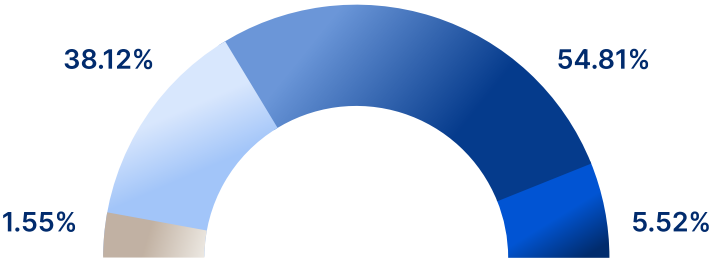

**PORTFOLIO GAP TO MARKET 41.09% TOTAL



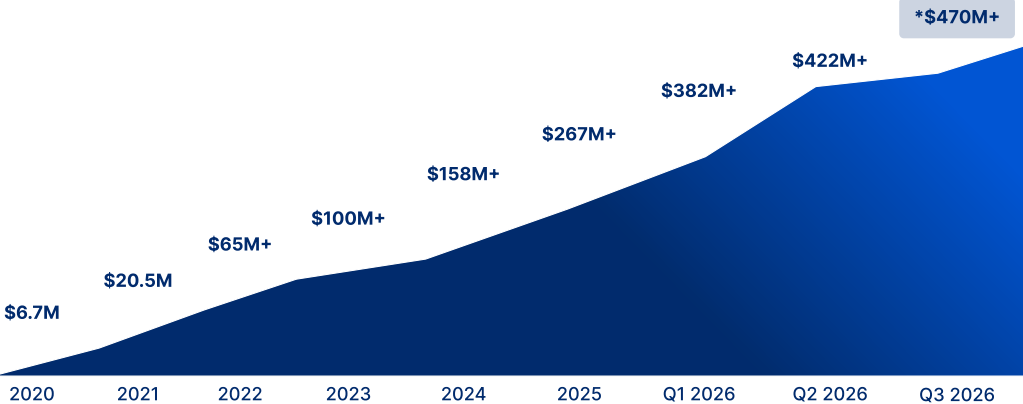
