Ruth Page School of Dance (RSPD) and Keystone Dance Academy (KDA) invite young dancers to join a fun, focused mini-intensive this summer. Students will work with teachers specially curated from RPSD, KDA, and throughout Chicago. Each week will feature a focused selection of beginner and intermediate dance techniques, including ballet, hip hop, jazz, tap, and West African, along with yoga and Pilates classes. Bootcamp concludes with a showcase in the Ruth Page Center theater and an Ice Cream Social Reception on the final day.

Registration is on a weekly basis – students may choose to attend for one or both weeks! Classes in the Summer Dance Bootcamp are not sold individually or by the day. Tuition is due in full on or before July 15th, 2026.

Optional lunches are available for an additional \$85 per week. Lunch menus will vary day to day. Please notify us of any dietary restrictions and mark your week selection on the back of this form. Lunches are not sold individually. Dancers who do not opt into this program will need to bring their own lunch.
