

# EDEN MEANDER “10 YEARS ONE OF A KIND” COMPETITION

## Terms and Conditions

The promoters of this competition are **Eden Meander Lifestyle Centre** and **Emerge Marketing** (“the Promoters”). By entering this competition, participants agree to these Terms and Conditions and consent to the collection and use of their personal information by the Promoters for the purpose of administering the competition, in compliance with the **Protection of Personal Information Act (POPIA) 2013**.

### 1. Eligibility

- The competition is open to **South African citizens aged 18 years or older**.
- Entrants must visit **Eden Meander Lifestyle Centre** in George to participate.
- Employees, tenants, contractors, immediate family members, and business associates of the Promoters are **not eligible** to enter.
- A valid **South African ID** will be required to claim any prize.

### 2. How to Enter

- Visit **Eden Meander Lifestyle Centre** between **29 October 2025 and 7 January 2026**.
- Scan the **QR code** displayed on-site to access the entry form.
- Complete and submit the **digital entry form** with all required details.
- Each valid entry will be automatically entered into a **lucky draw** to win a share of the total prize pool.
- **Entries are only accepted via the on-site QR code** and must be completed during the competition period.
- Multiple entries are permitted, but each must be submitted separately.

### 3. Prize

- Participants stand a chance to **win their share of R30,000 in vouchers from Eden Meander Lifestyle Centre’s stores**.
- Prizes are **non-transferable, non-negotiable, and cannot be exchanged for cash**.
- The Promoters reserve the right to **substitute prizes** with others of equal or greater value if necessary.
- Individual prize terms and conditions (as set by suppliers) will apply where relevant.

- The competition runs from **29 October 2025 to 7 January 2026**, during Eden Meander Lifestyle Centre's trading hours.
- Entries received outside this period will not be considered.

- Winners will be **notified telephonically** using the contact details provided on their entry form.
- If a winner cannot be reached within **48 hours**, or declines the prize, a **new winner** will be selected.
- Winners are required to collect their prizes from Eden Meander Lifestyle Centre. A valid South African ID must be presented when claiming a prize, and winners may be requested to participate in a photo opportunity for publicity purposes.

#### 6. General Terms

- The judges' decision is **final**, and no correspondence will be entered into.

- The competition is **governed by South African law**.
