



## ASIC registration fee Cashback

### Terms and conditions

#### 1. Applicability

These terms apply to the individual, acting as director of the newly formed company to be registered (Applicant, you, your) and the \$305 Cashback is subject to the eligibility criteria set out in these terms and conditions.

#### 2. Commencement and withdrawal

The promotion is called the ASIC registration fee Cashback (Cashback) and commenced on 15 December 2025 and continues until withdrawn. This Cashback is offered by ANNA Money Pty Ltd (ACN 681 600 073) of 212 Cumberland Street, Sydney NSW 2000 (ANNA Money).

ANNA Money may withdraw this Cashback offer at any time without notice.

#### 3. Eligibility

To be eligible for the Cashback, the Applicant must:

- 3.1. apply to register a proprietary limited (Pty Ltd) company using ANNA Money's company registration service available at  
<https://annamoney.au/services/company-registration>
- 3.2. successfully complete company registration with ASIC;
- 3.3. successfully open an ANNA Money Business Account and funded (i.e. topped up) within 7 days of company registration; and
- 3.4. complete a first transaction.

#### 4. ASIC registration fee

The ASIC registration fee is **AUD \$611 (incl GST)**, payable upfront by the Applicant.

This fee is a government-mandated ASIC fee and is not set, discounted, or controlled by ANNA Money. In view of this, the fee may be subject to changes at any time, such as an increase. If so, ANNA Money will update the pricing on its website. ANNA Money does not receive any commission, reward, or referral benefit in connection with this fee. ## 5. Cashback Offer

Subject to meeting all eligibility requirements under section 3, a Cashback of **AUD \$305** will be credited to the Applicant's company's newly opened Business Account.

The Cashback is not transferable, not redeemable for cash, and will only be applied after the completion of all eligibility conditions.

## 6. The Issuer

The ANNA Money Business Account is a non-cash payment facility issued by Hay Limited (ABN 34 629 037 403, AFSL 515459), and is subject to the ANNA Money [Business Account Terms and Conditions](#). By opening an account, you acknowledge having read and understood these Terms, and all associated financial disclosure documents ([PDS](#), [TMD](#), [FSG](#)).

## 7. Ineligibility

An Applicant will not be eligible for the Cashback if:

- 7.1. the company of the Applicant is not successfully registered or formed (a fee will not be charged in the first place);
- 7.2. payment of the ASIC registration fee is not successful;
- 7.3. the company of the Applicant is found to be involved, or engaging in any prohibited activity or prohibited purpose listed in Appendix 1 or Appendix 2 of the [ANNA Platform Customer Agreement](#) at the time of opening a business account;
- 7.4. ANNA Money discovers adverse information after company registration, either during or on completion of the business account onboarding, and wishes to exercise its right to termination under the ANNA Platform Customer Agreement; or
- 7.5. ANNA Money reasonably suspects duplicate applications, fraud, unlawful purpose, misuse of the Cashback, or receives information post-registration justifying account offboarding or closure.

## 8. No refund of ASIC fee

If an Applicant is ineligible for the Cashback, the ASIC registration fee of AUD \$611 remains payable in full. This fee is required by ASIC and is non-refundable by ANNA Money and all related documentation pertaining to the registration of the company will still be valid and provided.

## 9. Disputes and appeals

The Cashback is available under this Cashback until ANNA Money decides to end it. ANNA Money reserves the right to amend, suspend, or terminate the Cashback at any time, acting reasonably. Any changes will be reflected on the ANNA Money website.
