



ASIC registration fee Cashback

Terms and conditions

1. Applicability

These terms and conditions apply to the individual acting as director of the newly formed company to be registered (Applicant, you, your). The AUD \$305.50 Cashback is subject to the eligibility criteria set out in these terms and conditions.

2. Commencement and withdrawal

The promotion is called the **ASIC registration fee Cashback** (Cashback). It commenced on 15 December 2025 and continues until withdrawn.

This Cashback is offered by **ANNA Money Pty Ltd** (ACN 681 600 073) of 212 Cumberland Street, Sydney NSW 2000 (ANNA Money).

ANNA Money may withdraw this Cashback offer at any time without notice.

3. Eligibility

- A. To be eligible for the Cashback, the Applicant must:
1. Apply to register a proprietary limited (Pty Ltd) company using ANNA Money's company registration service available at <https://annamoney.au/services/company-registration>;
 2. Successfully complete company registration with ASIC;
 3. Successfully open an ANNA Money Business Account; and
 4. Fund your ANNA Money Business Account with at least AUD 50 and, within 14 calendar days of company registration, use your ANNA card to complete one or more business-related transactions totalling at least AUD 50.

To remain eligible for the Cashback, the ANNA Money Business Account must remain active by completing at least one outgoing transaction per week for the first 30 days following account opening.

The Cashback will be credited to the ANNA Money Business Account 30 days after account opening, provided all eligibility requirements have been met.

- B. To be eligible for the 50% off Virtual Office offer:



5. The Virtual Office option must be selected during the application process.
6. The Applicant must successfully open an ANNA Money Business Account.
7. Payment will be taken in full from your ANNA Business Account and will be credited \$38.50 each month if the account remains active
8. The discount will apply for up to 12 months while the account remains active.

For the purposes of this offer, an active account is one that completes at least one transaction per calendar month.

If the account does not remain active, the Virtual Office subscription will revert to the standard monthly fee of AUD \$70 plus GST.

4. ASIC registration fee

The ASIC registration fee is the government fee prescribed by ASIC from time to time and is payable upfront by the Applicant.

As at the date these terms were last updated, that fee is **AUD \$611**.

This fee is government-mandated and is not set, discounted or controlled by ANNA Money. If ASIC changes this fee, ANNA Money may update the pricing shown on its website accordingly. ANNA Money does not receive any commission, reward or referral benefit in connection with this fee.

Any new fee or charge set by the government is introduced or there is a change to an existing fee or charge set by the government.

The new fees will be reasonably promptly after the government notifies us, unless the government itself publicises the introduction or change, in which case we do not need to notify you.

5. Cashback Offer

Subject to the Applicant meeting all eligibility requirements in section 3, ANNA Money will credit **AUD \$305.50** to the company's ANNA Money Business Account 1 month after all eligibility conditions have been satisfied.

The Cashback is not transferable, not redeemable for cash, and will only be applied after all eligibility conditions have been met.



6. The Issuer

The ANNA Money Business Account is a non-cash payment facility issued by **Hay Limited** has authorised ANNA Money Pty Ltd ABN 71 681 600 073, AFSL 700143 (ANNA Money) to arrange, distribute, and deal in the non-cash payment financial products issued by Hay Limited (ABN 34 629 037 403, AFSL 515459) which includes The ANNA Money Business Account Terms and Conditions: <https://annamoney.au/hay-terms-and-conditions>

7. Ineligibility

An Applicant will not be eligible for the Cashback if:

1. the Applicant's company is not successfully registered or formed;
2. payment of the ASIC registration fee is not successful;
3. the Applicant's company does not successfully open an ANNA Money Business Account;
4. the Applicant's company is involved in, or is found to be engaging in, any prohibited activity or prohibited purpose listed in Appendix 1 or Appendix 2 of the ANNA Platform Customer Agreement at the time of opening the business account: <https://annamoney.au/terms-and-conditions/>;
5. ANNA Money discovers adverse information after company registration, either during or on completion of the business account onboarding, and exercises its rights under the ANNA Platform Customer Agreement;
6. ANNA Money reasonably suspects duplicate applications, fraud, unlawful purpose, or misuse of the Cashback; or
7. the ANNA Money Business Account is restricted, suspended, offboarded or closed before the Cashback is credited.

8. No refund of ASIC fee

If an Applicant is ineligible for the Cashback, the ASIC registration fee remains payable in full.

This fee is required by ASIC and is not refundable by ANNA Money. Any company registration documents or outputs validly produced as part of the registration process will remain valid and may still be provided.



9. Disputes and appeals

Applicants may dispute a Cashback ineligibility decision by contacting support@annamoney.au and setting out the reasons they believe they remain eligible.

All appeals will be reviewed on a case-by-case basis. Approval of an appeal or payment of a Cashback is not guaranteed. ANNA Money's decision will be final, acting reasonably.

10. Cashback changes and termination

The Cashback remains available until ANNA Money decides to end it.

ANNA Money reserves the right to amend, suspend or terminate the Cashback at any time, acting reasonably. Any changes will be reflected on the ANNA Money website.

11. Our liability

Our liability in connection with this Cashback, whether arising in contract, tort (including negligence), breach of statutory duty or otherwise, is subject to the following exclusions and limitations:

1. we are not liable for any default resulting directly or indirectly from any cause beyond our control;
2. we are not liable for any loss of profits, loss of business, or any indirect, consequential, special or punitive losses; and
3. we are not liable for any loss or damage caused by your act or omission.

Participation in the Cashback constitutes acceptance of these terms and conditions.
