## GENERAL INFORMATION

### Candidate Qualifications

Candidates must be UOSU members, as stipulated in the constitution.

Any UOSU member can run for election unless deemed to be ineligible under the Canada Not-for-profit Corporations Act, UOSU Constitution or Elections Code, or other applicable law or policy. Accordingly, the following persons are ineligible to be a candidate for the Executive Committee, Board of Directors, or Board of Governors:

- a. Anyone who is a UOSU member only by way of Article 4.1.2 of the Constitution;
- b. Anyone who is less than 18 years of age;
- c. Anyone who is incapable;
- d. A person who is not an individual; and
- e. A person who has the status of bankrupt.

Part-time students are ineligible to be a candidate for the uOttawa Board of Governors or Senate. Incumbents, excluding individuals serving in an interim capacity, are ineligible to be a candidate in a by-election.

Candidates may only contest one seat at a time and must run for election for the Board of Directors and Senate in their faculty.
