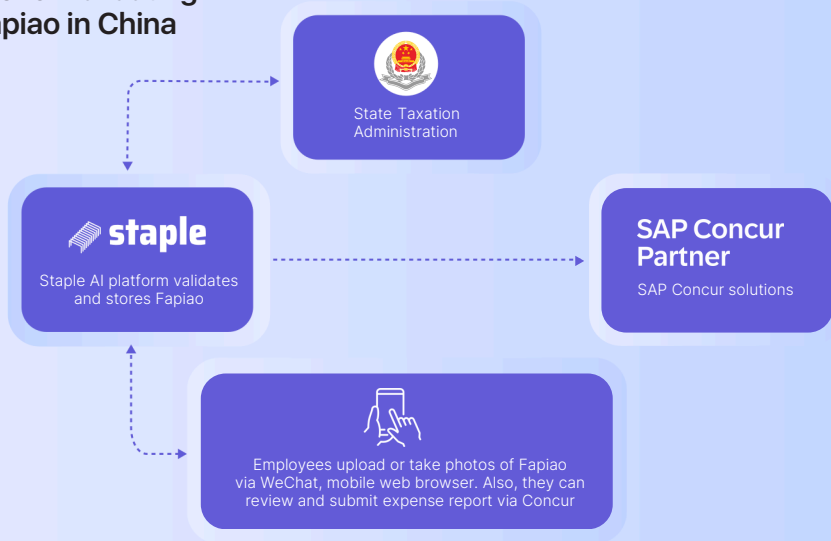

- 1 Validation and duplicate checks:** duplicate checks and authenticity checks should be applied to all VAT Fapiao.
- 2 Digital archiving:** e-Fapiao is now required by law to be digitally archived. Digital archives must also satisfy China's legal archiving requirements.
