

## Needs-Based Funding Distribution Arrangements for Al-Faisal College Ltd System

#### INTRODUCTION

Al-Faisal College Ltd (AFC) is the Approved System Authority ("the System") operating three Islamic schools in NSW, educating more than 4,000 students.

The schools offer families from all socio-economic backgrounds an affordable, quality school education option alongside those offered by government and other non-government schools.

AFC is experiencing strong growth in demand from families since establishing its first school in 1998. It plans to open additional schools in other parts of Sydney to meet this demand.

This document has been prepared in accordance with government requirements to provide public information on the distribution of recurrent government funding to AFC schools.

#### **FUNDING PRINCIPLES**

- 1. This needs-based funding distribution arrangement is based on the principles of transparency, accountability, sustainability and, above all, student need.
- 2. The System distributes all recurrent funding from the Australian and NSW Governments in compliance with the *Australian Education Act 2013* and *Australian Education Regulation 2013*.
- 3. The System undertakes needs-based funding arrangements that take account of the specific circumstances of each student in AFC schools. In line with Section 78(5) of the *Australian Education Act 2013*, these arrangements seek to minimise disadvantage, achieve high-quality education outcomes for each student and realise operational efficiencies.
- 4. To achieve efficiencies through economies of scale and maximise funds available for educational purposes, the System operates a central shared services model to undertake corporate support functions on behalf of each school including salary payments, HR management, administration and finance, marketing, ICT, workplace health and safety, quality assurance and compliance across all its schools.
- 5. In the event of special circumstances, such as a crisis or natural disaster, the System may seek an additional, temporary levy from schools for special purpose funding of schools.
- 6. All recurrent government funding received by the System is expended or committed to be expended on the education of AFC school students in the year that it is received.

#### NEEDS-BASED FUNDING ARRANGEMENT

- 1. The aim of this needs-based funding arrangement is to ensure each school is allocated the resources necessary to deliver optimum results and quality education to its students while maintaining financial sustainability.
- 2. As an Approved System Authority, AFC receives recurrent funding from both the Australian Government and the NSW Government at a "System" level, based on the Schooling Resource Standard (SRS) of each AFC school.
  - a. The Commonwealth Government calculates a notional per-student SRS funding level using a base amount per student (indexed annually) plus disadvantage loadings for up to six types of student and school characteristics.
  - b. The portion of the base amount per-student to be funded by government is reduced according to parents' "Capacity to Contribute" (CTC) at each school. This is estimated by the Commonwealth Government using de-identified income tax data to give each school a Direct Measure of Income (DMI) score. Each DMI score is assigned a corresponding CTC discount percentage for primary and secondary students, which reduces the base amount per student paid by government on behalf of each AFC school to the System.
- 3. The System uses each AFC school's total SRS funding as the basis for allocating each school with the staff and other resources necessary to deliver optimum results and quality education for its students.
- 4. An amount per student is retained by the System to support shared services functions and achieve operational efficiencies. Administrative costs are attributed to schools and reported in the annual Financial Questionnaire for publication on <a href="https://www.MySchool.edu.au">www.MySchool.edu.au</a>
- 5. The System also receives funding in the form of fees from parents and other private fundraising.
- 6. All fees and other income from private sources are also committed solely for school-related purposes. It is prudent to allocate some of these funds for future non-recurrent purposes, including:
  - a. reserves to ensure financial viability in the event of delays in receipt of payments, or other risks including unforeseen events
  - b. depreciation and amortisation expenses, which are of a non-cash nature but are necessary to cover future capital replacement and refurbishment costs
  - c. funds for new and expanded school facilities to meet enrolment demand from population growth and other factors
