TIPS & TRICKS TO BE WELL PREPARED

To make informed decisions regarding wastewater treatment, you need to have all the information. Whether you are considering changing your septic system or installing a system for a new construction, the following steps are essential to the success of your project.

TYPES OF TREATMENT

Depending on your property's environment and soil type, you will need one of the following types of treatment.



CONVENTIONAL

1

Treatment system consisting of a septic tank and a leaching bed.

The tank retains solids and the soil under the leach field removes the remaining pollutants from the water.

2 ADVANCED SECONDARY

An additional treatment unit is required to reduce pollutants to an acceptable level before discharge into the environment.

Requires annual maintenance according to the requirements of the Ministry of the Environment.



TERTIARY

3

Specific pollutants are required to be treated - faecal coliforms being the most common.

The Ministry of the Environment requires these systems to be maintained twice a year, with sampling of the discharge.

IDENTIFY YOUR NEEDS

Before starting the project, specify your needs to better guide your consultant.

Essential criteria


- Do I have a single-family home, a condo, a cottage, or something else?
- Will the dwelling be used seasonally or intermittently?
- Do I have a waste disposal unit, a well, a water softener?
- Do I have a business in my house (e.g. daycare, food processing, pet grooming)?

The types of terrain

- Is my land very small with close neighbors?
- Am I near a stream, a lake, or a ditch?
- Do I want to preserve trees?
- Am I in mountainous terrain?
- Will my septic system be higher than my house (pump required)?

THE PROJECT

STUDY

A consultant (technologist or engineer) will conduct a characterization study (also called a soil test) to determine if your land needs a conventional, advanced secondary, or tertiary treatment system and to meet the standards that protect our environment. We have a list of consultants to refer you to.

2 YOU CHOOSE

Your designer will propose all certified products that can meet your needs. You can choose the one that suits you according to your preferences such as durability, aesthetics, and media replacement costs. Finally, your designer will give you your implementation plans.

With the plans, you must obtain a permit from your municipality for the installation of a septic system.

Choose an installer (excavator) with an RBQ license under subcategory 2.4 (self-contained sanitation system contractor) and authorized by the chosen technology manufacturer. We can refer a qualified installer for you.

MAINTENANCE

All septic installations in Quebec must meet the requirements of the Ministry of the Environment.



EMPTYING

1

According to regulations, your septic tank or primary reactor must be emptied every two years. Sometimes, the municipality takes care of it and includes the costs in your property taxes. If not, you must deal with a septic tank pumper.

It is important to know that some municipalities allow pumping every four years for seasonal installations.

2 ANNUAL MAINTENANCE

According to regulations, the owner of a treatment system must be bound at all times by contract with the system manufacturer, its representative, or a qualified third party with the stipulation that a minimum annual maintenance of the system will be carried out to achieve the expected performance.

Cleaning of the effluent filter located in the septic tank or primary reactor is normally required twice a year (spring-fall) or more, depending on usage.

Composed of two concrete or plastic tanks, water circulates by gravity until it is discharged into the environment. The leaching bed, on the other hand, has an area 60% smaller than a conventional leaching field.











UPGRADING SYSTEMS...

When a septic system has reached the end of its useful life, meaning it no longer protects the environment, the municipality notifies the owner that it must be replaced.

Good news! A tax credit offered by the Quebec government is currently effective. Up to 20% of related expenses are eligible. Please note that septic installations as part of a new house are not eligible.
