

IN WAGES AND BENEFITS

In fiscal year 2024, the State of Oklahoma received more than \$210 million in exclusivity fees from tribal gaming operations under state-tribal compacts—an increase of 3.9% compared to the previous year.

These payments were based on over \$3.47 billion in revenue generated from Class III electronic games and non-house-banked card games, the Oklahoma Office of Management and Enterprise Services Gaming Compliance Unit reported.
