#### **Location & Situation**

The property is situated along Wawne Road within the suburb of Sutton-on-Hull. Netherhall is located approximately 3.5 miles north east of Hull and 8 miles south east of Beverley.

The surrounding area comprises predominantly residential with North Point Shopping Centre situated close by.

# **Description**

The property comprises of a two storey detached office premises situated within landscaped grounds formerly used by the NHS.

The immediate area is currently undergoing redevelopment to deliver approximately eight brand new bungalows to cater for supported living which include on site staff facilities. The property itself could serve a variety of uses particularly within the medical sector including private medical/GP surgery, dental practice and veterinary practices subject to planning.

The property appeals to both owner occupiers and developers with the property being suitable for redevelopment to other uses subject to planning.

# **Accommodation**

The total net internal accommodation available is approximately 4,256 sq. ft (395.40 sq. m).
