

## Hosting Clinic Responsibilities and Agreement

### **Purpose:**

This document outlines the responsibilities and expectations of the Hosting Clinic when partnering with Aesthetic National Institute (ANI) to conduct hands-on aesthetic injectable educational training. The Hosting Clinic agrees to provide the necessary support, infrastructure, and oversight to ensure the training event is conducted in a safe, ethical, and compliant manner.

### **1. Medical Clearance and Coverage of Training Models**

- The Hosting Clinic is responsible for the medical clearance of all training models to ensure they are appropriate candidates for the planned aesthetic treatments.
- The Hosting Clinic must maintain documentation that verifies model suitability and the absence of medical contraindications.
- The Hosting Clinic will assume responsibility for medical oversight and follow-up care only for models coordinated directly through the Hosting Clinic and treated under the Hosting Clinic's medical license.

### **2. Consent of Training Models**

- All models must be appropriately consented prior to receiving treatment.
- The Hosting Clinic will use informed consent forms that meet state and professional standards and identify the Hosting Clinic as the treating medical provider, outlining the nature of the procedure, risks, benefits, alternatives, and the fact that the procedure is being performed in a training setting.

### **3. Pre- and Post-Care Communication and Management**

- The Hosting Clinic is responsible for all pre-procedure communication, including pre-care instructions and answering any pre-treatment questions from the model.
- Post-procedure communication and management, including follow-up care and handling of complications or adverse events, must also be facilitated and managed by the Hosting Clinic only for models arranged by the clinic and treated under the Hosting Clinic's care.

### **4. Patient Education**

The Hosting Clinic is responsible for providing all models with proper education regarding the treatment being performed, including:

- Expected outcomes
- Recovery expectations
- Potential side effects
- When to seek medical attention

### **5. Medical Oversight and Provider Credentials**

All licensed medical providers participating in hands-on injections must:

- Be under the supervision of a licensed medical director authorized to practice in the state where the training occurs.
- Carry current and valid malpractice insurance covering aesthetic procedures.
- Attendees who bring their own models assume full and sole responsibility for those models, including medical clearance, informed consent, treatment outcomes, and follow-up care, and ANI assumes no responsibility for such models or treatments.
- The Hosting Clinic is not responsible for the actions, models, or patient outcomes of any training attendee.

## 6. Medical Supplies and Facility Use

The Hosting Clinic agrees to provide:

- Basic medical supplies necessary for training (e.g., gloves, gauze, antiseptic, sharps containers).
- Clean and suitable treatment rooms to accommodate training sessions.
- Proper biohazard disposal per OSHA and state regulations. All supplies must meet applicable regulatory and safety standards.

## 7. Liability and Indemnification

- Aesthetic National Institute (ANI) assumes no medical or clinical liability for medical complications, adverse reactions, or dissatisfaction related to treatments administered during the training.
- The Hosting Clinic and its providers are solely responsible for patient safety, treatment outcomes, and clinical follow-up for any models they manage.
- Each attendee is solely responsible for any treatment they perform during training, including compliance with scope of practice laws. Attendees must be under appropriate physician oversight and carry active malpractice insurance.

## **General Medical Supplies**

Alcohol prep pads

Antiseptic solution (e.g., chlorhexidine or puracyn)

Sterile gauze pads (2x2 and 4x4)

Bandages (e.g., Band-Aids)

Syringes (1 mL, 3 mL, 5 mL, 10mL)

Needles (30G, 27G, 25G –3/4 to 1")

Cannulas (22G, 25G 1/5 and 2")

Sharps containers (OSHA-compliant)

Ice packs or cold compresses

Arnica gel or tablets (optional)

Bacteriostatic sodium chloride

Mixer kits

Lido with Epi 1 or 2%
