



MEDICAL INJECTOR TRAINING AGREEMENT

This Medical Injector Training Agreement (“Agreement”) is entered into by and between **Aesthetic National Institute (ANI)** (“ANI”) and the undersigned trainee (“Trainee”), as of the date of execution below.

1. Eligibility and Licensing

The Trainee affirms and represents that they are:

- A **licensed medical professional** (MD, DO, NP, PA, or RN, as applicable) in good standing, with an **active and unrestricted license** in the state of practice.
- Covered by **current and valid medical malpractice insurance**.
- Practicing under an **active supervising or delegating medical director** as required by state law.

The Trainee agrees to provide ANI with all documentation necessary to verify licensing, malpractice coverage, and supervisory arrangements prior to commencing any training.

2. Purpose of Training

ANI provides educational training in medical aesthetic injection techniques. The training is **for educational purposes only** and does not constitute any guarantee of professional competency or certification. Completion of training does not imply that the Trainee is qualified to perform any procedures outside of their professional scope or state regulations.

3. Acknowledgment of Risk and Liability Waiver

The Trainee understands and acknowledges that:

- Participation in injector training involves hands-on procedures, including but not limited to, the use of needles, dermal fillers, neurotoxins, and related aesthetic medical devices.
- ANI, its instructors, owners, and affiliates **assume no responsibility for the clinical performance or patient outcomes** following completion of training.

The Trainee hereby releases, waives, and discharges ANI, its owners, employees, contractors, agents, and affiliates from any and all claims, liabilities, damages, costs, or losses arising from or related to the Trainee's participation in the training, including but not limited to personal injury, malpractice claims, or adverse outcomes with future patients.

4. Indemnification

The Trainee agrees to indemnify, defend, and hold harmless ANI, its owners, instructors, employees, agents, and affiliates from any and all claims, losses, damages, liabilities, or expenses (including attorney's fees) arising out of or related to:

- The Trainee's actions or omissions during or after training,
- The performance of aesthetic procedures on any person, or
- Any violation of laws or regulations by the Trainee.

5. Compliance and Supervision

The Trainee acknowledges that they will practice only within the **scope of their license** and under the **direction of their supervising or delegating medical director**. ANI is not responsible for ensuring the Trainee's compliance with state or federal laws.

6. No Employment Relationship

This training does not create an employment, partnership, or agency relationship between ANI and the Trainee.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the **laws of the State of Texas**, without regard to its conflict of law provisions.

8. Entire Agreement



This Agreement represents the entire understanding between ANI and the Trainee and supersedes all prior agreements, whether written or verbal.
