


## **IMPORT**



Empower support staff to bulk import Windows files & folders into iManage by targeting workspaces using profile information from datasheets



When attorneys/lawyers join a law firm, corporate legal department, or financial institution, they need the content from their previous business available in the new document management system (DMS) ASAP so that they can continue to manage their work with minimal business disruptions. #### **PRODUCT FEATURES:**

- Identify workspaces based upon unique identifying profile values as specified in the datasheet and import the content on the Windows file path into the identified workspace.
- Match the folder name with existing folders or create any non-matching folders.
- Maintain the integrity of top-level folders by importing non-matching top-level folders to a different folder.
- Specify the Author and Operator for individual workspaces via the datasheet.
- Perform a delta import when content has been modified and then import it as a new version or replace the original with the new material.
- Automatically inherit profile and security information from the parent location for metadata that hasn't been specified.
- Display all content imported in a task, including errors or warnings, via the import viewer.
- Utilize powerful filters on the import viewer to assist in locating and auditing the imported content.
- Import document profiles based on a profile datasheet
- Import documents to matching folders or place them under a sub-folder under the workspace specified
- Handle documents that are at the workspace/tab level by placing them under a specified folder
- Preserve the document's version from the source.
