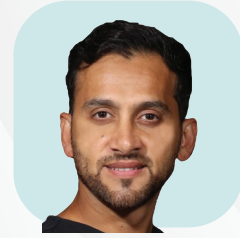

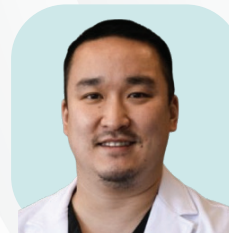

Each party agrees to be responsible for its own property through insurance or self-insurance and shall hold harmless Pikos Institute and the facilities in which the Pikos Institute meetings are being conducted for any damage caused by theft and those perils normally covered by fire and extended coverage policy.

Cancellation By Pikos
