

FIND YOUR AIDVANTAGE INFORMATION



MA REPAY PROGRAM



If you are a participant in the MA Repay Student Loan Repayment Program, you must submit your current loan information on the Eligibility Verification Form before your award can be sent to your loan servicer(s). This is required to verify your loans are eligible for repayment. If you have outstanding educational loans serviced by Aidvantage, follow the instructions below to find the loan information you will be required to submit.

STEP 1

Go to aidvantage.studentaid.gov and log in to your account. You must log in to this site. Screenshots from the Federal Student Aid portal will not be accepted.

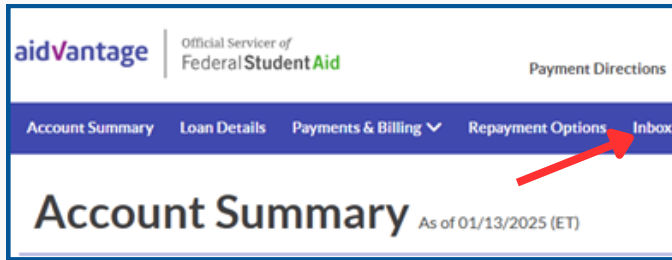

STEP 3

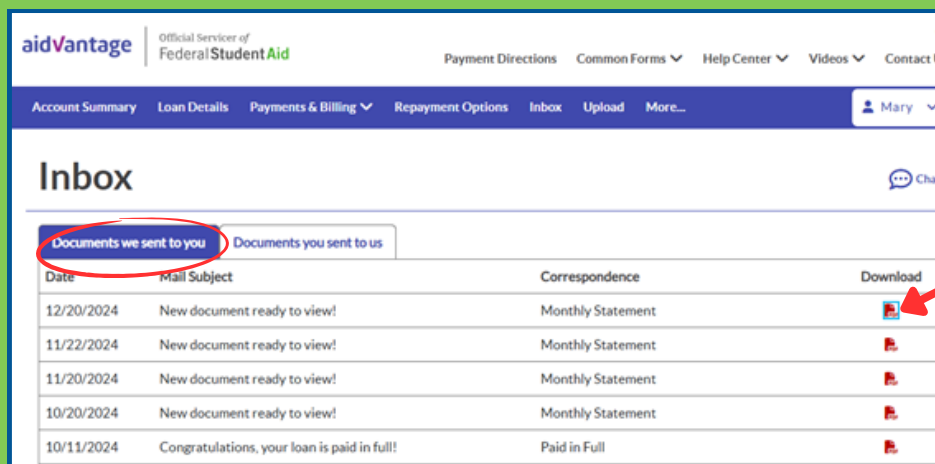
Navigate to the blue menu across the top of the page and **select the “Inbox” option.**



STEP 4

You will be brought to the Inbox page. This page shows the recent documents exchanged between you and Aidvantage. Under the “Documents we sent to you” tab, please find your most recent Monthly Statement. This statement will have “New document ready to view!” in the Mail Subject column and “Monthly Statement” in the Correspondence Column.

STEP 5

Download the Monthly Statement and save it to your device.

- The first page includes the Aidvantage branding and the borrower’s name, followed by an “Account Summary”
- The next page(s) includes tables with loan information
- The final page includes answers to frequently asked questions.

STEP 6

When completing the MA Repay Eligibility Verification Form, **upload the Monthly Statement as your Aidvantage Account Document.** You must upload the entire document. To be accepted, the document must include the borrower’s name, current balance, account number, loan type, and servicer branding. It must be dated within the past two months.

STEP 7

The Eligibility Verification Form also requires that you input the following information about your Aidvantage student loans:

- Servicer Name
- Servicer Payment Address
- Account Number
- Current Loan Balance

You may find this information on your Monthly Statement as indicated below. The example provided has been redacted for privacy.
