50.011, Fla. Stat.	No	N/A	Gives a governmental agency the option to publish legal notices on a publicly accessible website of a county instead of a print newspaper. A special district spanning the geographic boundaries of more than one county and opting to publish legal notices on a publicly accessible website must publish its legal notices on the publicly accessible website of each county it spans. The statute is self-effectuating.
106.133, Fla. Stat.	No	N/A	Prohibits a local government from expending public funds for any communication that is sent to electors concerning an issue that is subject to a vote of the electors. The prohibition applies to any communication initiated by the local government, regardless of whether the communication is limited to factual information. The statute is self-effectuating.
119.0725, Fla. Stat.	No	N/A	<p>Provides a public records exemption for coverage limits and deductible or self-insurance amounts of insurance or risk mitigation coverages acquired for the protection of information technology systems, operational technology systems or data of a local government. The new law also exempts information related to an agency's critical infrastructure.</p> <p>Any information related to an agency's network schematics, hardware and software configurations, or encryption information or details that identify detection, investigation or response practices or confirmed cybersecurity incidents are exempt under the law.</p> <p>Creates a public meeting exemption for any portion of a meeting that would reveal the confidential and exempt information described above. The meetings must be recorded and transcribed, but those records are exempt.</p> <p>The statute is self-effectuating.</p>

331.304, Fla. Stat.	No	N/A	Revises the names of specified former Air Force bases to reflect they are Space Force spaceport territory. The statute is self-effectuating.
331.3101, Fla. Stat.	No because Space Florida travel and expense Rules 57-50.001-003, F.A.C. currently exist and the new law effects only the 2022-23 fiscal year.	N/A	Revises requirements for Space Florida's annual report to the Legislature relating to expenses.  Revises requirements relating to travel and entertainment expenses of Space Florida. Prohibits Space Florida from expending certain funds for specified purposes. Provides a cap on lodging expenses for board members, staff, and employees of Space Florida under certain circumstances. Authorizes board members, staff, and employees of Space Florida to expend their own funds for lodging expenses in excess of the cap.  The statute is self-effectuating.
