No	N/A	The law creates a definition for a "public works project" which means an activity paid for with any state-appropriated funds or state funds administered by a governmental entity which consists of the construction, maintenance, repair, renovation, remodeling, or improvement of a building, road, street, sewer, storm drain, water system, site development, irrigation system, reclamation project, gas or electrical distribution system, gas or electrical substation, or other facility, project, or portion thereof owned in whole or in part by any governmental entity. The law establishes new requirements for the use of United Statesproduced iron and steel products in state funded public works projects. Florida local governments must include in their contracts for public works projects a requirement that any iron and steel product permanently incorporated in the project must by produced in the United States. No	N/A	Adds contract requirements to require a company acting as a "common carrier" to execute an attestation statement that the common carrier or contracted carrier is not willfully providing and will not willfully provide any service during the contract term in furtherance of transporting a person into the State of Florida knowing that the person is an unauthorized alien, except to facilitate the detention, removal, or departure of the person from this State or the United States.
