Welcome, Introductions &     Minutes Review & Approval	<ul> <li>Jennifer Marsh welcomed everyone, introduced herself, and asked all new attendees to do the same.</li> <li>Jennifer announced January 2025 will mark SAMHSA's first annual Substance Use Disorder (SUD) Treatment Month. SUD Treatment Month is an opportunity to reflect on our relationships with substances, learn about SUD and effective treatment options, and connect to resources. Jennifer stated there will be postings on the BHRS Instagram page throughout the month to promote awareness.</li> </ul>	
B. Overdose & Poisoning Data Infographic, Coroner Data and ODMAP	<ul> <li>Ritem shared information and reviewed the Substance Use in Stanislaus County infographic from October – December 2024. Jennifer reported on the Stanislaus County Overdose and Poisoning Deaths Coroner Preliminary Death Data on closed cases as of 1/7/25. There has been a total of 159 drug-related deaths in 2024, 92 were fentanyl related, 12 other Opioids, 44 Meth, 6 were alcohol related deaths, 3 were cocaine related deaths and 2 were other. Jennifer shared the number of deaths due to methamphetamine has increased and the number of deaths due to cocaine was added to the data. Jennifer will provide data by age group at next month's meeting. Jennifer also stated the number of closed cases is about 3 months behind and we should know the final number for the year 2024 in March or April of 2025 but based on the preliminary data for year-to-date numbers, the number of deaths for 2024 have decreased.</li> <li>Jennifer shared data from ODMAP. The data provided was for 2023 and 2024. The totals were by month, by day of the week and by hour of the day. Jennifer stated not all agencies are reporting into ODMAP, so these are underreported numbers. Jennifer will provide the number of Naloxone administered at next month's meeting. The data presented will be emailed to Coalition Members.</li> </ul>	
C. Presentations: SUD Initiatives, SB 43, Behavioral Health Plan, Opioid Settlement Funds	<ul> <li>Dr. Mora announced Senate Bill 43 went into effect on January 1, 2025, in Stanislaus County. Senate Bill 43 expands the definition of "grave disability" to include those individuals who are unable to care for their basic needs for health and safety due to a severe substance use disorder, or a co-occurring mental health disorder and a severe substance use disorder. 	<ul> <li>Mora stated they will be gathering information as the months go on and does not anticipate a major impact. Dr. Mora encouraged a heightened awareness of SUD treatments, resources and staff being able to connect those seeking SUD services.</li> <li>Tabitha Sprague reported in May 2023 BHRS obtained the Board of Supervisor's approval to utilize Opioid Settlement Funds to contribute toward the expansion of substance use disorder services. Tabitha provided information on the 4 phases of the planning process and stated due to multiple regulatory and DHCS Contract changes since initial proposal they have had to pivot in the planning process.</li> <li>Tabitha reported there has also been an update to the ASAM 4. The ASAM 4 goal is to better support the integration of physical and mental health care to promote a chronic care model of addiction treatment across all LOCs. There are new, removed, and updated services. Updated Dimensions for Evaluation of Service Needs and still pending Department of Health Care Services guidance. Tabitha went over ASAM recommended Strategies. The next step is to hold Stakeholder workgroups to coordinate planning for multiple initiatives and provide an updated Phased Plan proposal to the Board of Supervisors.</li> </ul>	
D. National Fentanyl Awareness Day 2025	Dennifer announced National Fentanyl Awareness Day will be in May 2025. Jennifer asked Coalition Members for ideas and suggestions to increase awareness. The following were suggested:  Vintage Faire Mall Empty Chair Display Stanislaus County Library Display May launch on TikTok. Post on Stanislaus County BHRS Instagram Display Empty Chair at high schools. Order One Pill Can Kill t-shirts and wear on NFAD and post picture. Rally at different parts of Modesto wearing One Pill Can Kill t-shirt from 12-1. Provide materials, Narcan. Art display at 1010 10th Street and provide award. Post on social media and request friends to repost. Hold a community march wearing One Pill Can Kill t-shirt. Participate in the Christmas parade. Participate in the Christmas parade. Participate in the Cinco de Mayo parade. Wear One Pill Can Kill t-shirt. Light the Night candlelight vigil. Expand the empty chair campaign and have businesses/organizations display at their offices or on the front sidewalk. A mascot named "Hope" to walk in the parade with the families would be amazing. I don't know what animal might be best to represent StanHOPE, but maybe a Lion for courage or a star for light.
